# Call for papers

Ageing is often discussed in the context of crises, both at individual and at societal level. People might, for example, experience age-related physical decline or change in social role as crises. Public and academic discourses frame as 'crises' issues in volunteering, pension sustainability, or health care demand and supply in the context of aging societies. Discussion of economic crises and demographic change often portrays ageing as a struggle with dwindling resources. Even highlighting what are intended to be positive approaches, such as active or successful aging, has been criticized as a potential source of individual crises, namely for those who, for a variety of reasons, are not easily classified as "productive" or "active". But are these various linkages between aging and crises justified? Do they foster solutions or do they cause new crises?

This conference brings together scholars from across Europe to discuss developments in ageing and old age. Such developments could, **for example**, relate to:

- Older workers, retirement, and pensions
- Formal and informal care arrangements
- Active and productive aging
- Social inequalities and poverty in old age
- Effect of population ageing on generational solidarity and welfare states
- Effects of the economic crisis and of globalization on life-courses
- Images, attitudes, coping-strategies and ageing.

We welcome quantitative, qualitative and conceptual papers. Contributions from scholars in the early stages of their careers are very welcome.

# Call for Papers Sociology of Childhood – Theorising Childhood

The Research Network, Sociology of Children and Childhood hereby announces the mid-term symposium which will take place in Jyväskylä (Finland) from 18<sup>th</sup> to 20th June, 2012. The organisation of the symposium will be undertaken at the University of Jyväskylä.

The focus of the symposium will be on **theorising childhood**. There are a growing number of empirical sociological and interdisciplinary studies of children in a wide variety of contexts where children live their lives. This has moved from school-based studies to those of children's everyday lives in their homes, playgrounds, online, as well as at schools and nurseries. The overarching approach of the social studies of childhood has been to perceive the actions of children in terms of children's own competences and this has led to a number of ground breaking insights into the worlds of children and their viewpoints and perspectives on matters that were traditionally deemed `beyond children's understanding'. However, with a few very notable exceptions, theorising these aspects has not followed to the extent of other sociological fields.

Although the focus of the symposium is around theorising childhood the papers for the sessions do not have to deal with the overall theme but is **open to all core areas of the sociology of childhood**. We invite experienced and young researchers from various disciplines sensitive to the sociology of childhood to participate. Although a particular focus to presentations and discussions will centre on theorising, participants are welcome to discuss also their implications for interdisciplinary work on childhood. Presentations can be related to the following areas:

- 1. `Sociological classics' (Marx, Durkheim, Weber) do they still matter?
- 2. Other classical theories of childhood and generation, such as Mannheim
- 3. New directions in sociological theory, such as network theories, normalisation processes, or the approaches of thinkers, such as Bourdieu, Foucault, Luhmann, Bauman, amongst others
- 4. The concept of spatiality in theorising childhood
- 5. How are rights, inequalities and injustices in childhood theorised?
- 6. How are theorisations around gender and ethnicity applied to children?
- 7. What is the role of theory in interdisciplinary work?
- 8. What are the questions of cultural identity and citizenship for children?

Please note there will be a conference fee to cover services (lunch, drinks, etc.) the number of delegates will also be restricted to 30 to enable discussion. The papers will be selected according to relevance to the theme of the symposium.

# **Argument**

The term "walk of shame" is deeply rooted in the idea that shame is a difficult emotion stemming from a feeling of inferiority or social discomfort, which causes a person to wish to disappear, become invisible, be "swallowed up by the earth". However, sometimes exactly at such a moment of disgrace, individuals are publicly exposed to the full extent of their misery and must walk "the walk of shame" witnessed by family, friends and acquaintances. Shame, considered by some to have genetic origins, is an integral part of social circumstances and settings in accordance with a set of values, patterns of thought and the individual's physiological makeup. Shame is the result of familial, social and media processes. Thus the walk of shame does not take place privately behind closed doors, but on city sidewalks, in the workplace, in newspaper columns and on television and computer screens. It is not surprising, then, to discover that the tremendous power of shame has expropriated it from the individual's control in the private sphere to the public sector, creating a collective punishing mechanism whose goal is to warn against undesirable behavior. Indeed, a person's public humiliation is a form of punishment, a negative sanction leading to disgrace, debasement and mortification. Such an act has a physical dimension as well as a media-based one. The physical damage involves negating a person's degree of freedom. The media-based damage involves widely publicizing the individual's disgrace. In both dimensions this damage creates a social imbalance in which individuals lose their former standing, i.e., their place in the public sphere prior to being subjected to the sanction of shame. Thus the person finds himself/herself in thrall to an external force (whether physical or

media-based) whose goal is to further specific interests. It is not surprising, then, that in ancient Greece Zeus dispatched Hermes to apportion to all human beings an equal amount of justice and shame, in order to facilitate their organization into societies and nations. In the thousands of years that have passed since then, people have transformed their sense of morality and shame into a tool with which to repress others and gather ever greater power (as is evident from Michel Foucault's writings on this topic in his book *The history of sexuality*).

However, in recent years we are witness to yet another phenomenon: the disgraced individual's attempt to change "the walk of shame" into the "walk of fame", from an act of humiliation to an act of glorification, from downgrade to upgrade. No longer a shameful crawl through back alleys, we now have a well-planned, carefully timed and rehearsed parade along the main thoroughfare of popular media. The marcher is transformed from a victim thrown to the lions to entertain the masses into a gladiator fighting for his life, placing his fate in the hands of readers and viewers.

As a result, the blurring of boundaries between the private and public spheres, following the expansion of celebrity culture and the proliferation of reality TV refugees, as well as the phenomenon of politicians chasing television screen time, has become multicultural and international. IT societies, as well as traditional cultures around the globe, are witness to well-known private and public figures, CEOs of financial organizations and companies side by side with high ranking political leaders, MPs and heads of state walking the walk of shame through newspapers headlines, paparazzi shots and of course prime-time television. Past struggles to achieve privacy, most commonly the morning after a night out at a bar, nightclub or party, have been replaced by a mass targeting of the public eye, while the victim simultaneously blames the media, and the public, for contributing to his or her degradation. Hence, this call for papers is targeted at original texts portraying current permutations (both qualitative and quantitative) of the walk of shame. These could include a wide range of multi-dimensional media phenomena focusing on political aspects, national discourse, financial crises, security leaks, sex scandals, embezzlement, treason and other kinds of cultural configurations.

# **Target Audience**

The target audience of this book would include professionals and researchers working in the field of social sciences, encompassing education, political science, information and communications sciences, etc.

# **Submission procedure**

**General guidelines:** All entries must be written in American English and typed in double-spaced Microsoft Word format (Times New Roman 12 pt. font). Texts in PDF format will not be accepted.

**Proposals:** Researchers and practitioners are invited to submit a 700-word chapter proposal which clearly outlines the mission and concerns of his/her proposed chapter. Each proposal should address one of the topics mentioned above. Proposals should be sent directly to the editors (<a href="mailto:moshe.corbu@gmail.com">moshe.corbu@gmail.com</a>) by January 31<sup>st</sup>, 2012. A separate cover sheet should be provided stating the name(s), institutional affiliation(s) and e-mail address(es) of the author(s). Authors whose proposals are accepted will be notified by March 15th, 2012.

**Completed chapters:** These should be submitted on or before June 15th, 2012. They should constitute high-quality original papers of a theoretical or empirical nature that shed light upon and engage with the topic of "The Walk of Shame". The submitted chapters should elaborate on the ideas and topics that were presented in contributors' proposals. Manuscripts should be prepared in strict accordance with the guidelines of the *Publication Manual of the American Psychological Association* (5<sup>th</sup> Edition). They should be a maximum of 9,000 words in length (including references, tables, figures, appendices and endnotes).

Contributors whose articles are accepted for publication will be obliged to sign a document specifying the publisher's terms and conditions, as well as a copyright agreement.

The fact that an abstract is accepted does not guarantee publication of the final manuscript. All chapters submitted will be judged on the basis of a double-blind reviewing process.

# **Overview:**

Current debates on gender, nation, sexuality, religion and other categories of social divisions and belonging often address the relations between these categories with the term 'intersectionality': intersecting in an infinite variety of ways, each of these categories helps construct all the others. What we are, what we suffer, what we belong to, or what we long to be, is multifaceted and contradictory. Our longings, or aversions, are related to our belongings in but complicated and ambiguous ways, and what social group or category we belong to does not determine our political or cultural values, goals or dreams. And yet: the former inform the latter, if only to the extent that we do not wish to remain tomorrow what we are today. Nor do our positionings, situatedness and belongings simply add up to an 'identity' (a being so and not other) – as if my hold of 'ethnicity no. 7' plus 'gender no. 2' plus 'citizenship in state no. 11' *etcetera* could ever equate to exactly what 'I am': 'citizenship in state no. 11' does not mean the same depending on whether I am of this or that sex, or sexuality, or age, or ethnicity. These intersections complicate, perhaps thwart, any efforts to ground the cultural and political projects, coalitions, emancipation that we long for in the spaces (physical, virtual, rhetorical) we belong to.

The organisers welcome critical contributions on all aspects of 'spaces of belonging' under the perspective of the concept of intersectionality. Theoretically informed contributions from scholars in all disciplines in the social sciences and humanities, broadly conceived, are invited, as well as from social and community activists or artists.

# "POLISH NEIGHBOURHOODS – THE CZECH REPUBLIC" that is to be held 19–20.04.2012 in Wrocław.

Although neighbourhoods are temporal phenomenon, one cannot but note that they set the social reality in order. Neighbours may not always be noticeable, yet they always are bearers of some emotional load. According to Richard Grathoff, "neighbours manifest themselves in a peculiar situation of intersubjectivity as the closest Others beyond the scope of the milieu. They delimit the milieu's borders and borderlands".

In November 1989, alongside the collapse of the Berlin wall, the process of the Polish contemporary neighbourhoods was initiated and it lasted until 1st January 1993. Thus for a few years (2009–2013) we are celebrating the 20th anniversary of the emergence of the Poland's seven new bordering states. This fact seems to entitle us for a deeper reflection, oriented mostly to social questions, over the two decades of these neighbourhoods functioning. A series of international scientific conferences is meant to make it happen, the first of which, regarding the Polish-Lithuanian neighbourhood, took place in 2011 (the book is forthcoming), while the second one is to be devoted to the Polish-Czech neighbourhood.

The vast material on the Polish borderlands – these bridges between the two states and their societies – that was able to be collected by the social researchers, makes one presume that the reflection on the Polish neighbourhoods will not be less fruitful. At the same time we hope that these findings will be welcomed not only by the Polish scientists, but also by the Lithuanian ones.

We would like to direct the problems of the conference to a wide group of scientists, but also journalists as well as other experts and representatives of the institutions dealing with the present, i.e. after 1989, face of the Polish-Czech neighbourhood seen through the prism of the social issues. Our ambition is to gather these people at the same time and site so that they could present their papers and exchange opinions. We plan that the meeting will be followed by a volume of reviewed articles. The organisers suggest that the papers presented relate to the following questions:

- social problems in the Polish-Czech transborderland;

- the Polish-Czech neighbourhood and the idea of Central Europe;
- the Polish plots in the Czech (and the Czech plots in the Polish) literature, art and film.
