#### **ESA 2015 Elections**

#### Election of the ESA President and Executive Committee Members,

#### 17-27 August 2015

#### Information about voting:

The Nomination committee of ESA has had wide consultations and asked for proposals for candidates from ESA members, from ESA RNs, and from the National Sociological Associations in Europe. Based on these consultations a slate of 26 candidates (11 men and 15 women) for the Executive Committee has been made, taking into account country representation and field of research. Due to the withdrawal in July of two candidates for Presidency, the nominations committee had to reopen the call for nominations from 15 July to 15 August.

All members of ESA in good standing (who have paid their membership fees by the time of the 12th ESA Conference in Prague, August 25-28, 2015) will vote for president of ESA and for members of the ESA Executive Committee for the next two years period.

Members may vote before the Conference or during the Conference (at the ESA voting desk near the registration on the first floor of the Faculty of Architecture – see the map below) by using the online voting system for 1 (one) candidate for the President and a maximum of 10 (ten) candidates for the Executive Committee. Members may also express their candidate preference by writing in the name (or names) of other ESA members in the list of candidates.

When the election starts, each voter will be emailed a message with a unique voting key. People who become ESA members after the beginning of the elections or during the conference in Prague will also be emailed a message with a unique voting key.

The voting starts on Monday, August 17, 2015 and ends on Thursday, August 27, 2015, at 12 o'clock (noon) at the 12th Conference of ESA to be held in Prague, Czech Republic. An ESA voting desk will be open during the Prague conference (at the ESA voting desk near the registration on the first floor of the Faculty of Architecture - see the map below) from Wednesday,

# **Proposed Changes in ESA Statutes**

# Approved during the General Assembly in Geneva (2011)

Dear ESA members,

As you know, during the course of 2015 there has been considerable email correspondence between the members of the various Research Networks and Ruth McDonald, Chair of the RNs Council and member of the Executive Committe, regarding changes in the statutes proposed by the previous Executive Committee, and not approved at the General Assembly in Turin in 2013. Ruth has communicated all the points of view, comments and proposals she has received to the Executive Committee. Other ESA members have written to the President directly or communicated their ideas to the Executive Committee.

The proposal enclosed is the result of this intense consultation. The changes proposed to the current statutes, approved in Geneva in 2011, are highlighted in green (changes in wording which do not alter the contents of the articles have not been highlighted).

Ethical Guidelines -proposed by the current Executive Committee - have also been added (see Annexe).

We would therefore like to invite all ESA members to comment on the proposed changes so that we can approve a shared version during the General Assembly in Prague. # How to Act Together: From Collective Engagement to Protest Belgrade, Serbia, 19-21 November 2015

# Description

The conference will explore the broad issue of action – in its various sociological and philosophical traditions – and the particular question of collective engagement in its contemporary forms of protest assemblies.

The question of action and human agency has been extensively debated in social theories of the 20th century. The pendulum moved many times from perspectives emphasizing social and economic determinants to those embracing human rationality, self-reflexivity and the ability to actively construct social reality. While some of the pioneer studies of action focused predominantly on micro-contexts and behavior of actors in concrete situations, the crucial question that social theory is facing today is how to once again shift the analysis from the level of individual action to the macrostructural one, i.e. the level of the 'behaviour of the social systems' - a shift which would escape the simple structural determinism of action and offer at least a horizon of the possible synthesis of the two analytical planes. The issues that interest us most in this respect concern the prospects of articulating social critique and reconceptualizing the 'political' from the perspective of individual and group action. How does one conceptualize adequately the 'everyday' action of individuals? What is the actual potential of concrete and engaged, albeit fragmented actions in bringing about general, systemic social change? Can social theory build on the actors' own accounts of their action as the grounds for the critique of power and domination? Finally, could we say that social theory amounts to no more than a methodologically adequate description of the potential for social critique inherent in everyday social action, or can it be an independent constituent of social engagement that brings about progressive change?

The question of action and agency was given a new impetus with recent waves of popular protests ranging from the so-called Arab spring to Occupy movements to anti-austerity protests. We want to see how these acts of collective engagement could be analyzed and interpreted within different traditions of thinking about action. Reversely, we also want to explore different impacts these new forms of engagement may have on theories of action. In particular, we wish to incite a debate on contemporary collective protests and theory of performativity, as it is advanced in Judith Butler's forthcoming book (Notes Toward a Performative Theory of Assembly), where it is revised to include "concerted actions of the body". What are the ways in which physical bodies can act in politics? How are we (and are we?) transforming and influencing the public and the politics by employing embodied ways of coming together? Finally, is precarity (precarious bodies) becoming a dominant force of protest, as Butler argues, or, on the contrary, is it the very obstacle to systemic change (tantamounting to "reserve army of labour")?

# Topics

Please send your paper proposals having in mind the following thematic clusters:

- Theories of action: philosophical, sociological, anthropological traditions
- The ontology of action and the questioned autonomy of actors: methodologies of approaching the action
- Action, social theory and social change: historical and disciplinary perspectives
- Who does the action, who thinks it through? The role of intellectuals, civil society, parties and other actors
- Public space and "public" bodies: thinking about the embodied ways of coming together
- Gendered bodies in public assemblies; gender, precarity and collective action

- Performativity and modern-day protest: changing the paradigm of the politics; from online organization (absent bodies) to conquering of public spaces (assemblies of bodies)
- Politics of resilience vs. politics of resistance challenging the conditions of precarity
- Radical solidarity: towards the new forms of political action

## Organization of the conference

The official language of the conference is **English**.

Presentations should not exceed 20 minutes.

The Program Committee of the conference will select the presenters based on the submitted abstracts. The book of abstracts will be published by the time of the conference. Conference **applications** should be sent only via e-mail to the following address: <u>conference@instifdt.bg.ac.rs</u> We kindly ask you to put in your email subject the following title: 'Your name: title of the paper'. The complete application in the .doc, .docx or .pdf format must contain: the title of the presentation, an abstract of up to 200 words and a short biography, in English.

There will be **no registration fees**. Conference organisers will provide lunch and light refreshments during the conference program. Participants are kindly requested to make their own accommodation and travel arrangements.

# **Poster + Presentation Submissions**

We invite submissions that describe research results or tools and methods for computational social science.

Exemplary topics for submissions include but are not limited to:

- Theories and models explaining the dynamics in social systems, networks, communities and teams
- Studies of political discourse and spread of opinions, attitudes and information on the web
- Studies of cultures and conflicts, segregation, discrimination, prejudice via new kinds of data
  Social-/Computational aspects of health, life style, sports and diet
- Social-/Computational aspects of human movement, mobility and urban planning
- Mixed methods and techniques (e.g. obtrusive/unobtrusive methods)
- Methods to deal with biased, selective and incomplete observational data on the Web
- Tools that detect and prevent mobbing or depressive behavior online
- Tools that support social scientists to capture, store and analyze social data on the Web
- Methods for the design and execution of online experiments for the social sciences

Other related topics are explicitly welcome.

Each accepted submission will be given a brief plenary time slot for presentation (e.g. during Pecha Kucha or short presentation sessions) as well as a poster stand during the joint poster session of the event.

The event will be non-archival (i.e. no proceedings).

Submissions should be 1-2 page abstracts (up to approx. 1000 words) summarizing the work to be presented. We encourage researchers to also submit mature work that has already been published and/or submit work-in-progress.

Submissions will mostly be evaluated based on relevance and the potential to stimulate interesting discussions.

The <u>PhD program in "Politics, Public Policies and Globalization</u>" deals with the main themes of contemporary democracy, from a range of interdisciplinary and comparative perspectives, including the historical, the sociological, the legal, the political, and the communicative. The program explores three specific areas, corresponding to three different curricula.

The curriculum **"Transformations of Democracy"** aims to investigate the democratic model in light of its main transformations, involving: changes in the forms of representation; the extension of suffrage; electoral systems; the relationship between the elites and the masses; the role of political parties; the role of the mass media, and especially of the new media, in the construction of consensus and of an informed public opinion.

The curriculum **"Democracy and New Welfare"** focuses on the links between democracy and welfare, looking in particular at the transformations which have taken place in the last century, and exploring a number of research topics, including institutional and legal frameworks, forms and structures of welfare, the evolution of civil rights, etc.

The curriculum **"Democracy and Globalization"** addresses issues such as the history and current dynamics of inter states relations; the philosophical and political assumptions underpinning those relations; attempts to implement a single international policy as to multilateral diplomacy and international relations; North-South relations and development cooperation; the role of culture, consensus and multilingualism in multiethnic societies and international relations.

The PhD program involves both institutional training and individual research.
