Call for Papers – Mid-term conference

Crisis, Resistance and Rights: Critical Political Economy Perspectives

12-13 September 2014, Vienna

The current crisis reveals one of capitalism's key contradictions: the relationship between rights, the state and society. Giving primacy to austerity politics, governments appear unable to guarantee basic rights vis-à-vis market forces. These developments constitute fundamental challenges to social eproduction. Governments have for example been pro-active in protecting banks' rights in foreclosures and housing evictions at the expense of people's right to housing, or imposed labour reforms marking a retreat of labour rights and rights to decent work. Similar trends can be observed with respect to welfare rights, the right to education, the right to water or democratic rights that go beyond ballot boxes, such as the right to protest and claim public spaces. Of particular importance here is also the political ecology dimension, with a focus on the financialisation of nature, enclosure of commons, and the green economy as a new hegemonic project. Resistance movements and civil society organisations/groups increasingly challenge private property rights and demand collective socioeconomic and human rights. Academic discussions of rights have long been a prerequisite of liberal political philosophy and received little attention from critical scholars. What can scholars in law, political economy, political science and sociology contribute to a critical understanding of rights? How does an emancipatory conception of rights look like? What are common rights, and/or rights to commons? How could such conceptions add to a critical understanding of crisis and resistance?

This two-day conference in Vienna seeks to explore interlinkages between crisis, resistance and rights in an open, genial and reflexive manner. We are interested in all of the above plus more, and wish for the conference to cover a wide range of topics. As such, we seek contributions from scholars with an interest in political economy research, regardless of their disciplinary affiliation and whether they are in academia or not. We also hope to attract a diverse range of participants, from a variety of countries and backgrounds. To this end, limited funds will be available for assisting PhD and early career scholars, especially those from Central and Eastern Europe, with their travel and accommodation costs.

There is no fee for attending and participating in the workshop. The workshop language will be English.

Abstracts of around 250 words should be submitted to cpern@criticalpoliticaleconomy.net by no later than 1 March 2014. The applicants will be informed of the selection committee's decision by 1 April 2014.

Towards a European Society? Boundaries, Borders, Barriers

The conference will take place in Zagreb, Croatia, 13 – 15 June 2014.

Theme

European society, with its inherent dilemmas, discontents, and horizons of opportunity, urgently demands the attention of the social sciences in general and sociology in particular. As the depth and breadth of cultural, social, economic and political ties across the boundaries of European national spaces increases at a greater velocity, the need for diverse representations of European citizens on the European and global level concomitantly grows. However, European social spaces emerge in multiple and fragmented forms, which necessarily contest the idea of cultural, territorial and political unity inherent in, and enforced by, the concept of "Europe" itself. Transnational spaces in Europe do not overlap simply with national domains; nor do they correspond to administratively determined regions of the EU. The challenges of imagining a European-wide public sphere or European civil society, as well as the idea of European integration through multi-level governance, have only increased as European political and economic boundaries widen and shift. Additionally, the entry of new member states has increased the range of social and economic inequality throughout the European Union by producing new political hierarchies and new barriers to the social integration of Europe. The political landscape of Europe might very well become even more complex if some 'old' member states seriously consider opting out even as new countries enter the EU. The first anniversary of Croatia's admittance in the EU is an appropriate occasion to discuss the present and future of European society, European citizenship, support for and alienation from the European integration project and the nature of emerging European social spaces.

Call for Papers: "The institutional foundations of distributed and open innovation"

Like economic behavior in general corporate innovation activities rest upon institutionalized rules, norms, routines and practices. Institutions are formative for the generation, distribution and allocation of knowledge and therefore essential for understanding innovation systems. For a long time innovation systems have predominantly been characterized by companies organizing their innovation activities inhouse in order to utilize their exclusive, proprietary knowledge to gain competitive advantages. On the societal level, these corporate strategies were embedded in a corresponding institutional framework. Now, for several reasons firms increasingly strive to integrate external resources into their processes of innovation and knowledge creation. Instead of concentrating on internal R&D processes they open up their innovation processes to make use of external sources of knowledge or take part in distributed knowledge production. Such innovation strategies, for instance, may include networking with other companies or cooperation with lead users in product development processes, utilization of user experience to develop new applications, or joint efforts in external communities.

The mini-conference focuses on institutional preconditions and consequences of such distributed or open innovation strategies. Open innovation strategies force companies to reorganize their innovation processes in a more dynamic and application-oriented way raising organizational challenges since established strategies are put into question. In particular, companies have to re-define the conditions for knowledge transfer as well as the interfaces between internal and a broad variety of external resources and actors, be it other companies and individuals or new actors and new contexts of knowledge production like networks and communities. The increasing relevance of distributed knowledge (production) raises the question of how companies attempt to frame and coordinate distributed innovation processes and inter-organizational knowledge transfer. This question does not only point to organizational conditions but also to the institutional foundations of innovation systems. Hence, the mini-conference invites papers – empirically or theoretically informed – that address the following questions:

- Which new actors and forms of collaboration in knowledge production do emerge? How do internal and external actors' roles, orientations and patterns of behavior change?
- How does the increasing incorporation of external actors (like customers and communities) into product development affect the companies' strategies? How do they go along with an on-going or even increasing competition between firms?
- To what extent do existing institutions enable or constrain distributed and open innovation processes? How do they change? How do corporate as well as external actors re-define and reinterpret existing institutions?
- Which new institutions facilitating distributed knowledge creation and transfer between internal and external actors do emerge?

Abstracts must be submitted by **January 20, 2014** via the online submission system on the SASE website. Candidates will be notified by February 17, 2014. Please note that Mini-Conferences require an extended (up to 1000 words) abstract, and ask that you submit a full paper by March 31, 2014.

Changing population: migration, reproduction and identity

University of Trento, June 3-5, 2014

The social sciences have long debated the use of racial, ethnic and national categories in analyzing processes of collective identity construction. Anthropology and Sociology have both contributed to uncovering the implicit essentialism underlying the racial and cultural definitions of difference conventionally used to identify, subdivide and classify human populations. At the same time, contemporary processes of social and cultural interconnection, fueled by intense global mobility, are challenging, bridging and overturning institutional boundaries of identity and belonging. National citizenship categories in particular have become increasingly limiting and constrictive in relation to the wide variety of reproductive practices individuals enact transnationally. Issues such as the family basis of migration, the fertility and birthrates of migrants and ethnic minorities, the rise in mixed marriages, the transnational spread of familial and kinship networks and the access to citizenship for "second generations" are only the most visible signs of a deeply rooted change, which impacts the composition and shape of national populations and triggers new citizenship claims.

Faced with these processes, dominant demographic discourse has adopted ethno-racial classifications and slipped easily into a rhetoric of danger: the danger of invasion, extinction, poverty and cultural disintegration. Still lacking or underdeveloped is a primarily social analysis of the demographic developments at play that draws on socio-anthropological research in order to problematize the demographic construction of minorities, in opposition to national demography; and, at the same time, that explores how individuals and communities ensure their own biological, social and cultural continuity despite and across ethno-national boundaries.

This conference aims to establish a space for international and interdisciplinary dialogue on contemporary socio-demographic shifts. We propose to focus in particular on the biopolitics of reproduction put in motion by both national governments, as they distinguish between citizens and non-citizens, and migrants and their descendents, as they affirm, negotiate or refrain from constructing their own definitions of family, kinship, genealogy and belonging.

In this perspective, which primarily addresses the intersection of reproduction and identity in relation to migrants and multicultural contexts, we invite papers exploring the following issues:

- The analytical categories and classifications employed in research on population, namely ethnicity, race, nation, culture and group;
- Demographic politics and systems for defining national populations;
- Family reunification and the ethno-national bases of welfare systems:
- The marriage practices, reproductive behavior and social genealogies of migrants and their descendents:
- Family planning policies and fertility management among migrants and minorities;
- Notions of identity and continuity in transnational migration.

The conference is organised by the SMMS Research Unit (Migration Scenarios and Social Change), Department of Sociology and Social Research, University of Trento.

Confirmed keynote speakers include David Kertzer and Pnina Werbner.

In gender-blind research, women's experiences and contributions remain invisible, and, consequently, important aspects of an issue remain undocumented and underestimated and, therefore, may be misunderstood (Leduc, 2009). Gender-sensitive research pays attention to the similarities and the differences between men and women's experiences and viewpoints, and gives equal value to each. It helps both men and women concerned by a problem to analyse an issue, understand its causes, and

find solutions. A gender-sensitive research methodology is usually more participatory and can contribute greatly to empowering people, notably women (Callamard, 1999; Leduc, 2009).

This session intends to explore the ways in which methodology can become gender-sensitive. Engendering research means that the gender dimension is mainstreamed into every component of the research: identifying the problem; defining the conceptual and analytical framework; choosing the methodology; analysing the findings; and disseminating the results.

More specifically, the session will focus on one or more of the following issues:

- aspects to take into consideration in the conceptual framework to avoid a male bias and to ensure a gender-sensitive approach;
- how to ensure gender-sensitive formulation of the research question;
- the definition of concepts;
- how to integrate gender issues into research: gender-sensitive data gathering methods and the use of qualitative and quantitative analysis tools;
- gender-sensitive research and the quantitative approach. A predilection for the qualitative approach has been consolidated among feminist scholars, while the logic of quantitative research has long been considered a gender-blind practice of male domination. However, quantitative research may greatly contribute to gender research. Moreover, contemporary sociology has made many efforts to overcome the rigid quality-quantity dualism;
- the use of gender sensitive language in the research report;
- the benefits of engendering social research;
- men, masculinities and research methodologies. Research on men and masculinities has grown exponentially in recent years. How can we address difference and diversity amongst men and between masculinities in our methodological approaches? (Pini and Pease, 2009).

Papers should address one (or more) of these issues, in terms of existing research, research development, best and new practices.

Religion is often discussed through the eyes of secularisation theory; however, there is no agreement on what secularisation is, or to what extent religion is present in our present lives even though religion is as influential as ever. Whether we understand secularisation as a decline of religious beliefs, privatization of religion, or as differentiation of the secular spheres and emancipation (Casanova 2006; Berger 2001), we still have to ask ourselves to what extent religion shapes our present lives. Many scholars believed religion will eventually loose importance and that societies will face decline of religious beliefs, but by the end of the 20th century many changed their views and acknowledged that secularisation theory does not work, and that religion is as important as ever (Berger, 1999). Nonetheless, we can agree with a view "religious communities have survived and even flourished to the degree that they have not tried to adapt themselves to the alleged requirements of a secularised world" (Berger, 1999: 4).

Recently, scholars also advocated that religion emerges in times of crisis such as, for example, the Arab Spring, breakup of former Yugoslavia, current economic crisis that is shaking the world etc. It is questionable whether we can truly discuss secularisation as a phenomenon, or we should simply turn our attention to the notion of religion in all of its aspects, and try to increase understanding of this complex phenomenon.

This issue's topic

FEEDING THE PLANET: ENERGY FOR LIFE

Feeding the planet that feeds us. This could seem a nonsensical invitation or yet another manifestation of human presumption. It refers instead to an imperative, where its deep meaning can only be understood once we consider its implicit circularity. It raises the problem of dual reciprocity at global level, between people and people, and between people and nature. It therefore brings up the basic issue of economic production in relation to the needs of feeding the world population, and the other no less significant issue of environmental sustainability in respect of this same production. In other words, in order to understand the sense of this circularity, we need to conduct a deep-rooted examination of the reasons why we are producing.

Reflecting on existence can, in actual fact, open us up to new areas of meaning and political action, especially when we clearly grasp the distance separating basic survival from the satisfaction of purely hedonistic demands. Positioned within this broad and infinite range of conditions, life shows its full political meaning, which, in current times, increasingly assumes specific bio-political connotations.

Ecology, the green economy and macro-policies of multinationals (or action of Nation-States becoming more and more ineffective) regarding food can be understood as a new form of global bio-politics. It no longer refers to being moved from "making live and letting die" to "letting live and making die", as Michel Foucault argued, but rather reaching "letting live and not letting die", by following bio-political practices that rediscover new ethical and value-based directions. And one that considers not only the human bios as its field of action, but also the natural: more specifically the natural bios, which includes the human one.

Biotechnologies, policies on health, reproduction and genetic programming are applied as much to nature, as to the human being. A new idea and corresponding bio-political action therefore needs to be clarified, based on responsible institutions and cognisant individuals. Far from being driven purely by economic interests, these would know how to look at life, both at a local level and on a global dimension, and from a perspective that is both holistic and territorially specific.

In respect of globalisation, then, what is the 'being' (historic and current) and the 'must be' in terms of agriculture, food practices and health education? What are the ideas and actions inspired by the principles of cooperation, environmental sustainability and global justice? What are the forms of living and eating together, which change with the intensification of human relations? What are the difficulties for the (currently predominant) urban population? What are the changes that refer to cities, and 'global cities', their networks and the surrounding territories?

The theme for the 2015 Milan Expo "Feeding the planet: energy for life" suggests these and many other problems. And never before when compared to this global era, each aspect takes on a significance in relation to the whole. While the whole can be only understood when we consider the reticular nature of its many and specific aspects.

Call for Submissions

Manuscript formatting requirements

Papers should be of 10-15 pages in length (1.0-spaced) including the following obligatory parts:

- 1) Author's full name and academic title(s).
- 2) Author's full affiliation (including, name of the department, faculty and university, address and e-mail address; if necessary point out the corresponding author). If the author affiliates him/herself with a business organization or institution, please, supply adequate information on the organisation's full title and address and e-mail address.
- 3) Title of the paper (capitalize each meaningful word).
- 4) An abstract (100-150 words) to disclose the main idea of the paper and your research results).
- 5) Keywords (up to 5 meaningful words/phrases). Always refer to the country(ies) of your research.
- 6) *JEL classification* (please, refer to http://www.aeaweb.org/jel/jel_class_system.php) for your keywords.
- 7) Introduction is an obligatory part of the paper, where the author(s) indicates the novelty of the topic and its urgent scientific solutions. The research goal should be clearly stated alongside with research tasks, research methodology, restrictions of the research and major sources of references. Indicate the logic of presenting your research material, e.g., define which section contains what information or research findings (theoretical and empirical).
- 8) The body of the text should be broken into meaningful sections with individual headings to disclose the essence of this section. Do not make the headings too long a preferable heading should contain 1-7 words.
- 9) Every paper should contain *Conclusions*, where the author(s) should conclude on the research material, without new facts or data. Implications for a future research might also find their place in Conclusions. Author(s) might opt for a section of *Discussion* or *Recommendations*, this practice is also welcome in our Journal.
- 10) References (see below).
- 11) In rare case we accept papers with extra explanations in *footnotes*. It is preferred that the author(s) keep(s) footnotes to a minimum.

Technical requirements

The text may contain *tables* and *figures*, which should have separate numbering (one numbering system for tables; another – for figures). They should be placed in the text at the appropriate paragraph (just after its reference) Never use or re-cite tables and figures of original authors, unless you receive a written permission from original authors/publishing house to include such tables and figures in your paper.
