Focus The theme of the Workshop follows that of the conference: *Differences, Inequalities and the Sociological Imagination.*

The Workshop will focus on the preparation of an article for publication. It will also address career development and provide peer mentoring and opportunities for creating networks with other European doctoral students.

Number of places: we will select 20 PhD students for the course.

Funding will be provided for 3 nights' accommodation (22nd, 23rd, 24th August) and meals in Prague. Up to Euro 300 will be available to each student towards their travel costs

Eligibility: Students registered for a PhD in sociology or allied discipline in a European University. Students must be an ESA member or become an ESA member before the Workshop. http://www.europeansociology.org/membership.html

Selection: Participants will be selected following a peer-review process and on the basis of scientific excellence of their proposed paper, but a fair balance between different regions of Europe and areas of sociology will also be considered.

Guidelines for applications: Complete the <u>application form</u> and a short CV (no more than 2 pages) and send them by email to Ellen Annandale <u>ellen.annandale@york.ac.uk</u> by February 9th 2015. Make sure that your application and CV are in Word (not pdf) format.

If you are selected: you will be required to submit a full paper (about 7,000 words) by 1st July to the workshop organizers. This is essential in order to make sure that participants get the most of this workshop; papers will be circulated in advance and allocated to peerdiscussants. We kindly ask you to apply only if you accept these terms of conditions and are prepared to follow the guidelines and deadlines.

Structures and Events – a Dialogue between

History and Sociology

7th Annual Seminar of the Bielefeld Graduate School in History and Sociology (BGHS),

29 June to 1 July 2015, Bielefeld University, Germany

What are structures? What are events? How do they relate to each other? These questions are of pivotal theoretical and methodological importance both in History and Sociology. They have informed and shaped debates between structuralist and (inter-)actionist theories and between structural and event history. More recently, approaches in both disciplines have begun to focus on the interplay and interdependence of structures and events. These approaches emphasise, for instance, the salience of social practices, cultures of commemoration, historical memories as well as path dependencies and critical junctures. They thereby make the complex and diverse entanglements of structures and events visible, both at the "macro"- and "micro"-levels: At the macro-level certain events disrupt and re-shape social, cultural, economic and political structures and sometimes become elements and/or causes of social transformations (e.g. revolutions, natural catastrophes, discoveries or inventions). At the micro-level, deliberate or accidental violations of behavioural norms can be described as critical events which make the vulnerability of norms visible but simultaneously contribute to their stabilisation and/or transformation. Finally, the interplay of global structures and local events, on which globalisation studies and global history focus, calls into question traditional micro/macro-dichotomies and poses the challenge of their theorisation.

The 7th BGHS Annual Seminar aims to deepen the dialogue between History and Sociology, and especially between junior scholars of both disciplines (PhD students and Postdoc-level) whose work tackles with the differences and entanglements of structures and events. Despite some notable exceptions, both History and Sociology have tended to study these issues within their disciplinary boundaries. The Annual Seminar intends to bring these different traditions of research together in order to identify promising lines of inquiry and to advance a more comprehensive and interdisciplinary understanding of how structures and events relate to each other.

We are therefore interested in theoretical, methodological as well as empirical papers from History and Sociology, but also from related disciplines like Anthropology, Ethnology or Political Science. In order to further the interdisciplinary dialogue we especially welcome papers comparing and combining approaches and insights from various disciplines. Possible topics and questions for papers may include, but are not limited to:

- Promising theoretical approaches: How do the different disciplines theorise and think about "structures" and "events" and the different ways in which they interlink and influence each other? How can approaches and insights from sociology help to better understand relevant questions in history and vice versa?
- Methodological issues: Are events to be construed as evidence, examples, illustrations or manifestations of structures? Can structures be described and studied without referring to events and vice versa? Can structures be reduced to sequences of events or are they to be considered as emergent phenomena?
- Crucial events: What makes some events more important than others? How do certain events become "shapers" or "makers" of social structures and social transformations? What role do

critical moments like lapses or faux pas in face-to-face interaction play not only in their immediate but also in a wider societal context? What do events like the French Revolution, the fall of the Berlin Wall, 9/11, the bankruptcy of Lehman Brothers or the Fukushima nuclear accident tell us about the interplay of structures and events and the possibility/capacity of events to influence and change structures?

- Global structures and local events, local structures and global events: How do global social, economic, political and cultural structures and events impact upon and shape local events and practices? How much "resistance" is possible for local practices and cultures in the face of global structures? And how do some local events become signifiers of globality (e.g. Olympic Games)?
- Historical memories in discourses about the present and future: What role do social and historical memories play in societal discourses and practices? How are some past events construed as "historical lessons" able to guide actors in apparently structurally similar situations (e.g. the Munich conference of 1938 and the effects of "appeasement politics")? How do societies observe and narrate their history and envisage their future and what relative weight do they thereby assign to key events (e.g. major wars, declarations of independence) and the continuity or change of certain structures (e.g. the contemporary idea of an ever-faster changing world)?

Please send your proposal (approx. 400 words) to annualseminar@uni-bielefeld.de by 31 January 2015. Authors of selected proposals will be notified no later than 28 February 2015. The conference papers (approx. 15 to 20 pages) are to be submitted by 15 June 2015.

The BGHS will cover accommodation costs. Participants may additionally apply for a grant for their travel expenses if they have no other institutional sources of funding.

Sexual Landscapes of Childhood and Youth

Sociological Studies of Children and Youth announces an edited volume that will chart the sexual landscapes of children's and young people's lives. In contemporary cultures, both sexuality and childhood are presumed to be natural parts of our lives, while also seeming to require our constant vigilance. And, even as they share much, sexuality and childhood often seem to be at odds. Sexuality is positioned as outside of idealized childhoods, threatening to corrupt children's innocence; manyimagine the move from childhood to youth to necessarily entail entering a treacherous sexual terrain.

This timely volume will engage the work of scholars committed to interrogating conventional understandings of sexuality, childhood, and youth. Chapters will respond to the positioning of sex and sexuality as ever pervasive and corrosive in children's contemporary lives and the associated social, political and moral debates that emerge. Analyses will foreground sexuality, gender, and race in constructions of childhood and youth and consider the complicated relationship among agency, intimacy, citizenship, and regulation in children's and young people's lives.

The guest editors welcome theoretical papers as well as those that draw on empirical research. We are especially interested in papers that promote the views and experiences of children and young people in a debate wheretheir voices are often peculiarly quiet. We seek papers that resist the impulse to homogenize children, youth, and their sexual worlds by considering multiple masculinities, femininities, and sexualities.

Less Europe, different Europe(s) The controversial discourses of Europe

Comunicazione Politica monograph issue 3/2015 Editor Marinella Belluati (University of Turin)

Feelings of scepticism and criticism towards the project of European integration have been playing a prominent role within the European public space. The 2014 elections in particular turned into an occasion to express the negative moods and growing disaffection together with antipolitical feelings and new forms of populism that are spreading throughout Europe.

The project of European integration, especially at these times of economic crisis, does not seem to be perceived with the same level of positivity with which it was often welcomed in the past. Such positive approach was often too hasty and premature, as demonstrated by the "permissive consensus" thesis. But the critical approach, openly supported by national political parties and populist movements, can hide the real nature of the phenomenon and remove those elements of complexity that help understanding the new season of Europe and Europeism. Alongside Euro sceptical narratives reported in the media and by anti-European party leaders, according to the European statistics the general level of trust in Europe is growing, as it is seen as a form of protection from the crisis while providing possibilities of institutional modernization. Moreover, the evaluation concerning the European institutions and policies is positive as in many countries the EU shows performances that prove more efficient and effective than the national ones. It would be difficult to argue that the integration phase is not moving forward. There is a process of Europeanization of social systems and public opinions that can be observed more clearly in social practices rather than in cultural elaborations and which progresses notwithstanding political resistance and the lack of ability that media systems show when attempting to narrate it. This process consists in individual experiences, mobility for workers and students, marriages and new unions, integrated communication flows – such as for example the web. This is made possible by the existence of a common currency, a growingly open circulation space and a lingua Franca, English, which supplanted the idea of common language. This engenders a growing need for integrated policies and rules valid across all the EU countries.

But all this is hardly ever found in public and political speeches, reported and reinforced in the media who rather prefer to fuel the rhetoric of a distant and cold Europe to boost their internal consensus, a Europe that is a constraint rather than a resource, a product of banks and bureaucracy rather than a creation of citizens. There is undoubtedly some truth in this, but there is also the systematic removal of a different horizon.

The goal of this monograph is to bring together works that well explain the coexistence of such contrasting tensions. We would like to foreground the structural and narrative elements that keep being an obstacle to the affirmation of the European public sphere and that fuel the European lack of democracy, which is well rooted in the nationalistic rhetoric and the national institutions that are not ready to give up their power. As we often hear, the economic and financial agreements are not enough to create and strengthen a feeling of European citizenship; it is necessary to strengthen the political space and, according to Habermas, the voice of intellectuals who should fight populism and be supported by serious media outlets, to build good social representation. The latest elections legitimized the presence of Euro-sceptical political feelings: even though they have not taken a prominent role in the European institutional architecture - the anti-European parties are experiencing quite a few difficulties in creating coalitions across Euro-parliamentary groups - they are nevertheless letting a negative narrative emerge and this is spreading across politics and influencing the society at large. Still, it must be said that the space of Euro-criticism is ill-defined and lacks cohesion, bringing together extreme positions such as those of the Lega Nord and the Front National, sharing similar definitions, those of the British UKIP or Alba Dorada, openly hostile and contrary to Europe, and those who may be labelled as progressive such as Tzipras Other Europe or the Podemos movement, which gave a voice to the Indignados, together with the new transnational environmentalist or consumerist movements. All these are signals that a cognitive mobilization is taking place around Europe and calls for deeper understanding.

Starting from these tenets, the ComPol monograph is looking forward to collect analytical contributions dialectically exploring the tension between contrasting elements of pressure and resistance to the construction process of a European public space. Contributions focusing on the following topics will be welcomed:

- The 2014 European Elections
- Transnational experience of political organizations and leadership, with an anti-European approach or aiming for a European re-foundation
- The European public sphere building debate and its actors
- The sentiments of trust or mistrust in Europe (quantity and quality approaches).
- The European communication flows (media representation, public communication and integrated media systems)
- The European communication of national public actors (parties, governments, civil society)
- The European deliberation decision processes

An abstract of max 500 words must be sent by 31st January 2015 (compol.rivista@gmail.com). Proposals will be selected by the 28th February.

Complete manuscripts must be sent by 15th June 2015 and they will be subjected to a double blind peer review.

Short Summary

The proposed project will aim to advance our knowledge about young adults in Europe, their values, norms, expectations, needs and political ambitions.

Through comparison with older generations, research will identify the intergenerational differences regarding the organisation of economic, social, political and private life in Europe.

This will contribute to public policies designed to meet the challenge of transition into a more sustainable economic, political and social model that will at the same time respond to the needs and expectations of young people. It will also identify the areas where education could play a role in shaping attitudes of young people towards the necessary evolution of our lifestyles.

Project Structure

The project will utilize both traditional research methodologies as well as action research and technology supported data collection. Data will be gathered with different means such as with the use of questionnaires, with the use of an online platform (E-Agora) and by engaging the youth in structured democratic dialogues (SDD). The above will allow the comparison of the information gathered by these different techniques.

FWC is an expert in the SDD Methodology. The partners that we seek will need to provide expertise in the design of the traditional data collection and data analysis.

Questionnaires will be delivered in approximately 7 countries with numbers ranging between 500-1500 per country depending on population size. The science partners of this project will however be in charge or designing the questionnaires, deciding the target populations and analysing the results. The actual data collection process will be subcontracted to a professional European consulting and research company.

Context

The Summer school will bring together senior scholars, postdoctoral students, and Ph.D candidates for an intensive four-day exchange on new historical and sociological approaches to European Studies. The school will be held in the extraordinary setting of the Moulin d'Andée (http://www.moulinande.com) located on the banks of the Seine in Normandy, one hour outside of Paris. It will be a unique opportunity for in-depth empirical, methodological and conceptual discussions on the study of the European Union and an occasion to strengthen and broaden existing European networks of scholars.

The Summer school will take stock of the rapid evolutions of the past 10 years in the field of EU studies and will sketch out shared research agendas. Until quite recently, work in history, political science and sociology developed quite independently, but disciplinary boundaries have gradually softened and shifted. A number of political scientists developed approaches inspired by political sociology and socio-historical perspectives; simultaneously, a new historiography of European integration has emerged with a generation of historians from Germany, Denmark, France and elsewhere, who developed and explored more sociological perspectives and methods (transnational networks, field theory, etc...). These historians have called for closer collaboration between the disciplines as a way to renew the field of EU studies and study the blind spots of existing paradigms.

Sociology had until recently remained on the sidelines, but recent research on professions and configurations of elites in their relationship to the "European project" have provided new avenues for closer cooperation with political sociology and history.

Overall, these innovations have generated several new insights: a more historically grounded perspective which places contemporary transformations in their context of historical possibility; a more actor-centered orientation which questions the porosity of social spaces affected by European institutions while embedding "European actors" in wider social spaces; a more empirically-focused research agenda, opening black boxes and conceptualizing central ideas of the European process as the result of actor mobilization and legitimation strategies; last but not least, a more reflexive posture able to question forms of entanglement and circulation between an emerging transnational academic field and EU-implicated fields.

Objectives

The residential Summer school follows three objectives. The first is the diffusion of new research concepts, methods and research techniques which have developed in parallel within the different disciplines (historical sociology, field-theory, prosopography, articulation between quantitative and qualitative methodologies, etc.). The second is the development of forms of reflexivity of EU academics, a domain which has remained for the most part a blind spot of EU Studies, but which has recently become a topic of research interest regarding the "making of the European Union". The third is to consolidate and to take stock of recent developments in cross-disciplinary research and identify some shared research agendas and objects for future research.

Organization

The Summer school will be organized around 6 half-day themes and a final round table spanning over 4 days (9-12 June 2015). Each half-day (3 hours) will be dedicated to a theme which will follow the same structure: a keynote presentation of 45 minutes by a senior researcher will focus on the state of the art, methodological questions, research practice and perspectives; a discussion of two or three papers which operationalize the concept or method being discussed; an open discussion with all the participants. The sessions will be structured as follows:

- 1) Socio-historical approach of EU polity formation
- 2) EU Studies and the "European project": "dangerous liaisons"?
- 3) Field-theory in Brussels: opportunities and difficulties
- 4) Sociography and prosopography of European actors
- 5) Studying European public spaces
- 6) Transnational circulations and transfers
- 7) Final Round table

Application process

The Summer school is open to all members of the European academic community interested in developing their skills or participating in these interdisciplinary discussions and perspectives. This includes senior researchers or lecturers, post-doctoral students, PhD students and research engineers. We plan to bring together a total of 30-35 participants. **Discussions will be held in French and English.**

"la Caixa" Prize in Social Sciences

Objectives of the prize

The aim of the "la Caixa" Prize in Social Sciences is to advance analysis and debate on the transformations that contemporary society faces. This could relate to social, environmental, technological and health related challenges, or a combination of this. Through this competition, "la Caixa" will reward studies of proven scientific and academic quality and will contribute to their dissemination by publishing them.

Requirements

- Participant studies will focus on the social context from a Spanish or international comparative perspective.
- The studies must include an analysis of empirical data generated by the author/ authors, although studies which analyze empirical data obtained from secondary sources will also be accepted.
- Work that has been previously published or awarded a similar prize will not be accepted.
- Studies must be finished and ready for publication.
- Studies can be submitted in English, Spanish or Catalan.
- Submissions must be around 145,000 characters (spaces included).

Candidates

The prize is aimed at both researchers or research groups linked to a university institution or a public or private research body.

Topics

Primary consideration will be given to studies within the following research frameworks:

Social change and the life course

Studies regarding the analysis of social change in certain life stages or related to principal life transitions in family contexts.

Social cohesion

Studies that analyse social exclusion and its determinants, as well as its manifestations in poverty, isolation, marginalization and violence.

Education and citizenship

Studies aimed at the analysis of the role of formal and informal education in the formation of citizenry and in civic, political and associative participation, as well as in the building of competencies for active citizenship.

Health and quality of life

Studies related to public health, quality of life, the welfare of individuals and populations, the prevention of illness and improving the health care system.

Information Society

Studies that analyze the social impact in the public and private spheres of information and communication technologies (ICT), access to ICT or their new uses and applications.

Urban planning, the environment and sustainable development

Studies related to the social dimension of sustainable development and the interrelationships between the environment, ecological crisis and the production and use of resources.

Globalization, poverty and social exclusion

Studies that analyze, with an international approach, the impact on poverty and inequality resulting from globalization and the growing socioeconomic interdependencies.

Presentation of studies

The studies must follow the rules for presentation of original texts and style found at http://obrasocial.lacaixa.es/laCaixaFoundation/socialsciences_en.html, in the section corresponding to the prize.

The study should be sent as a PDF document to the following email: social-studies@fundacionlacaixa.org. The name or names of the author or authors must not be included anywhere in the document. In addition, the following documents (also in PDF format, identified only by the title of the study and without any names or personal data) must also be submitted:

- An abstract of the study of no more than 1,000 characters.
- An outline of the potential social impact of the results of the study.

Furthermore, these two identification documents must also be submitted in PDF format:

- A letter with the title of the study and personal and professional information regarding the author or authors. The letter must express the candidate's intention to participate in the competition for the social science prize and acceptance of the rules regarding the awarding of the prize as well as of the decision of the jury. It must also include a statement indicating that the work has not been previously published and, in the case of being awarded the prize, granting all publishing rights to "la Caixa" Welfare Projects. The author must sign the letter; if the authorship is collective, all the authors must sign.
- A brief professional curriculum vitae for all the authors, including publications and competitive research projects related to the topic of the project they have participated in during the last five years (no more than 2,500 characters per author).

The author or authors will only be identified once the jury has awarded the prize. The identities of the authors will remain unknown to the jury as they examine the studies.

Deadline for online submission

The deadline for the entry of works will be 31 March 2015.

Granting and publicizing of the prize

The prize is 15,000 euros and includes the publication of the winning study.

The award-winning study will undergo a process of peer review and, if necessary, will be revised by the authors.

The prize will be paid in two instalments: 50% when the decision of the jury is made public and the other 50% when "la Caixa" Welfare Projects grants approval for the publication of the study.

The award of the prize implies, in all cases, granting all rights to the work for its publication in any medium or language. "la Caixa" Welfare Projects may authorize the authors to carry out adaptations or subsequent editions of the work as long as the awarding of the prize by "la Caixa" is mentioned.

In the case of multiple authors, the authors will indicate what percentage of the prize corresponds to each. If not indicated, it is understood that the prize will be shared equally among all of the authors.

The prize is subject to the withholding of taxes established by current legislation.

Jury and resolution

The jury will be comprised of experts from different fields in the social sciences. The decision of the jury will be made by a simple majority and is final. By agreeing to participate, candidates waive any challenge to the decision of the jury or any action against these criteria. The award may be declared void at the discretion of the jury.

The jury's decision will be communicated by email to all candidates on 15 May 2015. The prizewinning author or authors may not make public statements regarding their work or make known its results and conclusions until the study is published.

Europe needs a change. Within the project Welfare, Wealth and Work for Europe (WWWforEurope) a group of 34 research institutions has taken up the task to design a sustainable and inclusive growth and development path for Europe. Now the program is approaching its decisive final phase. Some topics which have proven to be important are considerably under researched in the literature and, also, in the project.
