The concept of the conference's topic:

The existence of the dispositional military, paramilitary and civilian groups in social systems became a reality defined by the challenges associated with the development of civilization in modern states.

People in highly developed societies in terms of civilization tend to increase their sense of security not only through personal prevention of various threats but also through creation of measures which allow to overcome the outcomes of events resulting from a variety of threats which could not be foreseen and avoided. This is why individual states create their own security systems which protect their population from potential external and internal threats.

Various foreign countries or terrorist groups can be the source of the external threats. Military dispositional groups are needed to overcome such threats. However, in order to overcome internal threats such as various natural disasters and existing social problems different specialized paramilitary and civilian groups are needed.

So far the experience has shown that the best results in overcoming potential threats and their effects are achieved when all useful dispositional groups are involved. However, the effectiveness of any collective action depends on good coordination and cooperation of each dispositional group. For these reasons, we believe that the issues concerning the smooth interaction between dispositional groups are so important that it is worth having an academic conference to which we invite those interested in this issue.

- Cooperation of dispositional groups in the face of environmental, civil and socio-political threats.

- The issue of cooperation of dispositional security structures (e.g., Army, Police, Border Agency, Prison Service, State Fire Brigade, Volunteer Fire Brigade, Mountain Volunteer Ambulance Service and Medical Emergency Rescue and Technical Service).

- Voluntary institutions which ensure security in the face of local threats.

- Dispositional groups in an urban natural and social environment (Medical Emergency Rescue, various technical services such as Gas or Power Emergency Services, etc.).

- Security in the face of the threats of social balance (risk, crisis and disaster).

- Rescue simulations and joint exercises which integrate different formations of the security system.

- Specificity of training the members of dispositional group in the security subsystems.

- Factors influencing the content of training programs for safety systems in the structures of their dispositional groups.

- A multidisciplinary approach to the problems of safety systems at local, regional and international levels.

- Other research areas incorporating the scientific mainstream of the conference.

CONFERENCE ANNOUNCEMENT AND CALL FOR PAPERS

The 21st annual workshop of the European Research Network on Transitions in Youth will take place in Berlin (Germany) on 11-14 September 2013. The workshop will be hosted by the research institute WZB (Wissenschaftszentrum Berlin für Sozialforschung).

The Network welcomes contributions on all aspects of the transition from youth to adulthood, and particularly the transition from education to the labour market. Contributions are particularly welcome on the theme for this year's workshop, which is:

School-to-Work Transitions in Times of Economic Crisis: Causes, Consequences and Remedies

Since 2009, the economic crisis has put pressure on national economies and labour markets all over the world, but the burdens are unequally distributed among different social groups. Young people are among those who tend to suffer most heavily from economic downturns. However, as in times of prosperity, the consequences for young people vary considerably across countries. In some countries, the youth unemployment rate recently exceeded a level of 50%, while in others we hardly observe a remarkable increase. Institutional factors and their interrelations play a crucial role in how they catalyse the crisis' impacts across different national contexts.

Many governments are launching various policy initiatives to tackle the severe consequences the crisis has had on youth labour markets. Job guarantees or training measures for youth have been introduced. Depending on the institutional framework, these measures show diverse results for different groups of young people. As an integral part of labour market entry processes, such policies and their effects should be thoroughly understood.

The main objective of the TIY network is to advance our theoretical and empirical understanding of transitions in youth. Among these transitions, those between the education system and the labour market are of particular interest because they prove to be especially important in generating and reproducing social inequalities. We favour a comparative perspective as well as the use of cross-sectional and longitudinal data-sets regarding schoolto-work transitions.

Because the tensions on youth labour markets have persisted for a couple of years now, school-towork transition research should be able to present robust results about these topics. Papers may have a theoretical and empirical focus or show methodological improvements with respect to the main theme.

The following topics are of particular interest:

- What are the expected (long-term) consequences of the crisis for young people in terms of labour market integration, social inequality, family formation etc.?

- What have we learned from other crises?
- Which role do educational and labour market institutions play in buffering or fostering the severe consequences of the economic crisis?
- What are the effects of policy measures introduced to tackle youth disadvantages?

- What is the particular role of vocational education and training in protecting young people during the crisis?

- How does the crisis affect patterns of social inequalities linked to social class, gender and ethnicity?

The Network Committee does not regard this list of suggested themes as a complete, let alone exclusive, list of topics to be addressed. On the contrary, the Network Committee welcomes contributions on all aspects of the transition from youth to adulthood or the transition from education to the labour market.

Anyone who wishes to present a paper at the workshop should send a one-page abstract by email to the address indicated below by 15 March, 2013. In keeping with our usual procedures, abstracts will be assessed for selection by the members of the Network Committee on the basis of their quality and relevance to the theme of the workshop. Authors will be notified of the decision regarding their paper by 30 April, 2013 at the latest.

The conference fee is set at €550 and includes four nights of accommodation (single room), lunches and social events (including conference dinner). Since only a limited number of places will be available, anyone who wishes to attend the conference without presenting a paper should notify the conference organisers as soon as possible. In order to ensure the smooth running of the workshop, participants should register and pay the conference fee before 1 June, 2013 to be guaranteed accommodation organized by the workshop staff. The information on the starting date for registration and payment will be provided on the webpage www.wzb.eu/tiy2013 on 1 March, 2013.

For papers to be made available in advance to workshop participants, final (electronic) versions should reach the local organisers at the very latest by 15 August, 2013.

Rescaling immigration paths: Emerging settlement patterns beyond gateway cities

Deadline: September 30, 2013

<u>Sociologica</u> will publish a symposium entitled "Rescaling immigration paths: Emerging settlement patterns beyond gateway cities."

In some countries, including the US and other countries in Europe, there is a growing interest for recent trends of immigrant settlement, which seems to be directed toward new destinations different from the main metropolitan gateways that have been attracting new populations for decades now. These new places of arrival are often smaller cities or towns that rank lower in the urban hierarchies in comparison to traditional gateways, but are not necessarily rural areas.

This circumstance suggests new theoretical and empirical questions regarding the roles of host economies and societies in immigrant networks and settlement patterns: Which structural processes lie behind this "territorial superdiversity?" Is it a wave of "deflection" from old gateways, or is it due to

specific pull factors in the rescaling geography of economy and governance? Is there a specificity in the social, political, and economic inclusion/exclusion of migrants in new destinations?

These issues have been analyzed by an emerging, though still limited, literature, often in a quite fragmented way within different academic communities, with a lack of comprehensive views beyond local cases and specific dimensions (settlement patterns and networks, societal reception, institutional coping and political reactions, economic participation). This could hinder a thorough understanding of the mechanisms underlying new settlement processes, with an under-theorization of a wider range of factors not just connected with migration patterns.

For instance, as the title of this call suggests, interesting theoretical insights and inputs for field research and analysis can come from the study of territorial governance, state rescaling, and neoliberalization of spaces affecting the (re-)making of boundaries; from its dialectic relationship with grassroots mobilization and transnational social networks; and from the placement of migrant and transnational networks themselves within the mobilities paradigm (i.e., analyzing the importance of movements in the construction of identities, in inclusion and exclusion processes, and in its relation with fluxes of goods, capitals, and information.)

In this respect, this symposium aims at shedding more light on this issue by collecting papers that:

- account for the structuring of the phenomenon in different national and regional contexts with attention not just to sociographic dimensions but mainly to underlying social factors;

- compare different national and regional contexts to find evidence of general trends, divergences, and convergences; and

- highlight potential progress in sociological theory and methodology.

Asking for motives and offering motives

As a rule, people present motives if challenged to account for their behaviour. People make use of vocabularies of motive (Mills, 1940) to present (meaningful and justified) actions to other people who stand to evaluate them. The motives asked for and motives given in return are shaped in three different contexts (Johnatan Potter & Hepburn, 2008):

- A rhetorical context: one formulates motives with an eye to the plausibility of alternative versions, some of which one may want to entertain, and some of which one may want to undermine;

- An interactional context: people give motives as specific answers to specific questions, as part of ongoing interaction in which they have something at stake;

- An institutional context: the interactions in which people are asked to formulate motives may vary widely as regards their accountability rules; one can be in a school, at the doctors, in a Courtroom, with a counsellor, at Alcoholic Anonymous, etc.

Some research questions that may address this topic include (without being by any means exclusive): 1) What are the vocabularies of motive or interpretive repertoires (Jonathan Potter & Wetherell, 1987) associated with a given type of action (such as smoking, accepting a scientific theory, divorcing etc.)?

2) How are motives used to coordinate interaction?

3) How are motives rhetorically formulated, in order to support a version of reality in interaction with specific interlocutors in specific situations?

Motives and motivation

People often anticipate specific reactions to specific actions, including answers to questions about motives. They design some activities such as to 'motivate' other people in a certain direction, to frame their situations and environments in order to direct them. Such 'motivational' actions make visible the order on which they are based, the order that grounds expectations.

Possible questions related to this topic include:

1) How do people present a specific situation or action to others, in order to motivate them to react in a preferred way?

2) What are the lay and (quasi-)scientific theories of motivation that people bring to bear in their daily interactions with others?

3) How are motives embedded in objects? How do users adapt and react to these pre-programmed motives?

Working with motives as a professional

There is a vast body of research and literature on motivation, including motivating oneself, in fields such as psychology, sociology, consumer research, human resources, human-computer interaction, education studies and so on. Some motivational schemes have reached global fame, including Maslow's pyramid of motives or Hertzberg's hygiene or motivational factors. Professionals in various fields design, apply and evaluate complex models of human motivation, and embed them in their more-or-less material products.

We welcome papers that discuss the production and use of professional vocabularies of motive, and the reactions of various publics to the socio-technical systems that put them into practice. Some guiding questions include:

- How do we (and other specialists) study motives, in disciplinary and interdisciplinary research?

- How do professionals' public products (technologies, policies, clothing, scientific theories...) incorporate specific models of human motivation?

- What is the 'moral career' of motivational classifications, in various spheres of life – such as Maslow's pyramid, or the distinction between intrinsic and extrinsic motivation?

- How do we encounter and react to professional motivational designs in various institutional environments?

Social research relies on our claims of understanding people – which often rely, further, on the claims advanced by our research participants (as respondents, informants, subjects, or in other roles) of understanding themselves and other people.

At times, we are also confronted, as researchers and in other walks of life, with difficulties, failures, and outright impossibilities of understanding people.

We invite papers that reflect on forms of understanding, misunderstanding and not understanding people. Articles that have a comparative focus, by looking at different forms, instances, settings etc., are especially welcome.

Some of the questions that may guide discussion include (without being limited to) the following:

- **Different forms:** What forms and claims of understanding, not understanding, misunderstanding, uncertain understanding, better understanding etc. *have we encountered* in our research?

- **Rhetorical use:** How do people report their understanding of other people as *arguments in conversations*? How do claims of understanding, misunderstanding, not understanding, uncertain understanding, partial understanding etc. function as arguments that support one's stance and undermine alternative versions? What is the rhetorical force of these various claims of understanding and lack thereof?

- **Social organization**: How are these forms of understanding and not understanding socially organized? What social positions (such a professionals, parents, friends, spouses etc) are privileged in claiming understanding of particular other people? When and how do alternative understandings clash, and how are these conflicts adjudicated?

- **Professional versus common reason**: How is our *professional* understanding of people related to the common-reason forms of understanding and lack thereof of the people that we rely on – as subjects, informants, respondents etc? How do we position our understanding to be better? How do we elicit their understanding?

- **Techniques and technologies**: How do we operate with theories, schemes and models, methods, techniques, instruments of understanding people? How do other people operate with such *tools*? What do we (and others) take to be more or less reliable *indicators* of other people's thoughts, personalities, motives, ways of being? How do we elicit and / or read CVs, photos, Facebook profiles, test results, biographies, obituaries, interviews, and other would-be ways of understanding people?

- **Different perspectives**: How do different theoretical or disciplinary perspectives shape our understanding of people? What are the benefits and the threats of drawing on, and combining, different *disciplinary perspectives* in our research papers/studies?

Articles that engage in a comparative approach, connecting different concepts, materials, methods, situations, pieces of research or other social realities, are particularly welcome.
