New directions in health care work and organisations

In contemporary societies, the social organisation of healthcare is facing many challenges that may lead to fundamental transformations. Major challenges emerge from global economic trends towards marketization and the ways most States are restructuring the public sector. Side effects are already taking place, in particular how work is structured and organizations compete in the context of limited recourses. Consequences are set also on the side of users. However, it must not undermined that some fields in healthcare and players may face expansion and new opportunities in this context, namely those linked to technologies and management. In sum, changing policies and governance result in comprehensive challenges to the social organisation of healthcare that warrant further attention, including different models of governance; greater involvement of technologies; the emergency of new health professions and competition for professional jurisdictions; the incentive of private healthcare systems; possible implications for users in the access to and consumption of healthcare. This new directions may vary within and among countries and globally.

We invite the submission of SESSION PROPOSALS addressing these issues from any area of sociology of health and illness, either in comparative perspectives or in one dimension. If you are interested in organising a session please send the proposal including: title, the call for papers (no more than 150 words); name and full contact details of the session organizer and, if appropriate, up to two co-organizers (names, affiliations, country, e-mails) by email (as word file) to the ESA RN16 programme coordinator Helena Serra (helena.serra@fcsh.unl.pt) and co-coordinator Tiago Correia (Tiago.Correia@iscte.pt) no later than **30 June 2015**.

Decision on the final selection of sessions will be made by the ESA RN16 Board in August 2015. The selected Call for Papers will be launched in September 2015 and abstracts invited for submission via the ESA online system.

The RC54 Sessions at the Third World Forum of Sociology seek to explore the multifaceted nature of space, time and the body in order to question the ways in which we construct, experience and understand our world. We encourage an examination of time, space and/the body as inter-connecting areas of embodied people who constantly participate in specific tasks, at particular times and in constructed spaces. Our aim is to take advantage of our mutual experience and know-how in order to identify the optimum content for the Forum.

In order to strengthen the ongoing scientific collaboration between the sociology of the body and a systematic promotion of innovative best practices, we intend to develop a set of tools, techniques and strategies aiming at producing a dynamic sample of culture as negotiating across collective practices and behaviors. We will work to intervene socially for a successful integration by focusing on the factors that shape and constrain the development of wide-ranging public policies and civil initiatives more embedded in habitus, bio-social equilibrium, sense and perception. Our task will be, therefore, to achieving an interdisciplinary frame of exchanges and experiences throughout a methodological crossing, working along the following three axes:

A declined comparison of different spatial and temporal scales [local, regional, national, international];

A circulation of data between countries and disciplines;

An implementation of survey protocols and tools [numeric, artistic and audiovisual] in the collection of fresh data.

A strong support by an empirically based research will be the essential prerequisite to pursue the following articulated strategies:

To invent an innovative grammar by mapping the practices of embodiment;

To create and share new methodologies for the study of the human body that meet the challenges of entirely new ways in which the issue of embodiment is now appearing in the contemporary world;

To provide an avenue of communication between scholars and practitioners in fields such as medicine, nutrition, sport, urban planning and technology development, and to communicate findings of research, currently too often trapped within the academic community, to policy makers, planners and the public;

To stimulate fresh research on the subject of the body in society and nature.

Recognising that different disciplines and practitioners express themselves in different mediums, we welcome traditional papers, panels, workshop proposals and other forms of performance (as can be accommodated in the space provided). Accordingly, topics are sought on different aspects and/or relationships between any combination of space, time or the body or on how these realities are understood and constructed in order to affect, effect, order and/or control each other.

Invited topics can include any of the following themes and related areas:

1. Contexts for Space, Time and the Body

Architecture: the Construction and Constraints of Space; Work and Power as a Temporal-Spatial Event; Time and the Spatiality of Movement; City Planning and Change Over Time or Terrain.

2. Experiencing Time, Space and the Body

Time 'Performativity' ; Religion and Ritual; Real-time Tracking of the Human Body; Time-space Routines and Biological Rhythms.

3. Travel (and Tourism) as Motors for Body Movement

Travel and Tourism Geography; The Ethics of Tourism; Ecotourism; Health, Tourism and Hospitality.

4. Sport

Body Clock and Sporting Peak Performance Lifestyle Training Health Related to Sport Exercise; Sport Nutrition and Exercise Metabolism.

5. Time in Health and Illness

Trauma: New Forms of Social Suffering; Age and the Impact of Space and Time; Artificial Organs and Therapeutic Interventions; Diet and Health, Anorexia and Obesity.

The taste for revenge, whether morsel or dish served cold, is something people, groups and nations, and even animals desire. Since time immemorial, individuals and communities have done justice by harming those who have harmed them, despite the costs, and the avengers immortalised as heroes and villains. While the hurts and methods for addressing them may differ, blood feuds, the killing of Osama bin Laden, and revenge porn are all motivated by the need to get even.

This interdisciplinary conference will ask who seeks revenge and why, how it is done, how it is justified, how it is represented, how it feels to get revenge or be on the receiving end. This includes revenge starting with the smallest workplace slights, through family disputes and lynch mobs, to political violence, war and terrorism. We invite contributions, including those not in the academic paper format, from any area of biological, human and social sciences, arts and humanities, and more, that are related to topics including but not limited to:

- interpersonal revenge, state revenge, collective punishment
- technologies of revenge
- revenge cultures, blood feuds, and informal justice
- revenge, politics and world history
- revenge, terrorism, armed conflict and retaliation
- the personal and social costs of revenge
- revenge, justice and injustice
- revenge in art, literature and media

This is a multimedia event, and will be contributing to the production of a documentary on revenge by Rex Bloomstein and Justin Temple (RexEntertainment) as well as traditional academic outputs.

Thinking Beyond Capitalism

How is it at all possible to make sound statements about contemporary capitalism? How does one adequately diagnose the current state of the economy? Clearly there is no consensus whether the financial crisis which culminated in 2007-2008 should be seen as a symptom of the structural crisis of neoliberal capitalism only, or of capitalism in general. Moreover, one should keep in mind that the term 'crisis' is itself laden with different ideologems. The talk of 'crisis' implies the existence of a superior prior state of capitalism, free of any crisis, and that we are now witnessing an extraordinary phase which is alien to the 'normal functioning' of the system. Should we understand the crisis merely as the means for restructuring the existing system, or as the beginning of an irreversible demise of the current mode of production? Is it possible that the crisis has actually enabled the exacom preservation of the status quo, and has prevented any change? Or was the crisis, on the contrary, the crucial catalyst for the politicization of the otherwise depoliticized actors within late capitalism? We are thus simultaneously exposed to various institutional-reformist suggestions, more or less grounded apologias, and identifications of fundamental contradictions within the capitalist reproduction process. In The Communist Manifesto Marx argues that capitalism is a social order which arises and subsists in the form of a critique of all alternative orders and subjective dispositions. Capitalism has proven more radical than its competitors: it has destroyed the ancien régime, has rendered all societal bonds flexible and has constantly revolutionized the means of production. It is a system in which 'all that is solid melts into air, all that is holy is profaned'. To what extent, then, is it even possible to formulate a critique of such societal system, a system that has managed to incorporate critique itself? Can one stage a revolution against the 'revolution' itself? If capitalism thus emerges as the actual constitutive framework of our thought, how do we begin to think beyond capitalism?

Starting from the assumption that crises are in fact situations which open up space for thought rather than obstruct it, we intend to thematize the following spectrum of problems:

- Difficulties regarding the self-valorization of capital
- Inequalities within the global division of labour and the challenges of (re)distribution
- Reproduction of social classes and forms of domination
- Structural unemployment and the growth of the precariat
- Tensions between market imperatives
- Ideologems of management, esprit d'enterprise...
- The transformed property relations characterizing 'non-material goods'
- Geographical aspects of capitalism (territories, borders, etc.)
- Tensions between the centres, semiperipheries and peripheries of capitalism
- Dangers of climate change
- Competing dimensions of normativity (universal, global, particular, local, singular...)

- Democracies versus authoritarian social orders
- The cultural dimensions of neoliberalism
- Critique of ideology, critical discourse analysis of neoliberalism
- Neoliberal patriarchy and the new feminisms
- The rise and evolution of anti-neoliberal / anti-capitalist movements
- Left, right, and Romanticist anti-capitalism
- Alternative modes of production of social life today

Organization of the conference

The conference is organized by the Group for the Study of Social Engagement, part of the Institute for Philosophy and Social Theory in Belgrade, with the support of the Serbian Ministry of Education, Science and Technological Development, Centre for Advanced Studies in Rijeka, Croatia, the Centre for Ethics, Law and Applied Philosophy in Belgrade, and the French Institute in Serbia. The official language of the conference is **English**.

Presentations should not exceed 20 minutes.

The Program Committee of the conference will select the presenters based on the submitted

abstracts. The book of abstracts will be published by the time of the conference.

Workshop 35: Dynamics of political public spheres: Diagnosis meets Epistemology

Workshop-Organizers : Kornelia Hahn (University of Salzburg/ Austria) Andreas Langenohl (University of Giessen/ Germany)

The workshop aims to challenge most recent concepts of the transformation of the public by discussing approaches and methods on how to analyze public political discourses and practices. In contrast to depicting 'the' public as a given research entity, we suggest to focus on processes of negotiating the political public sphere with special reference to the current phenomenon of (de-) regulation. The following aspects urge us to rethink the viability of classical concepts of the public:

- the constitution of political public spheres, classically conceived as a macro-model of political communication, needs rethinking towards micro-logical processes with special attention to digital media communication.

- the public/private antagonism: while the notion of the boundaries between 'private' and 'public' has played a crucial role in depicting the political sphere in modern societies, we must account for recent debates about the political 'protection' of privacy (for instance, private data) in order to reassess the conceptual status of that boundary

- revisiting the confrontation between 'serious' public discourse and entertainment: how can we grasp the potential salience of entertainment formats in their quality as idioms of politically informed debate and critique?

We invite contributions that address current phenomena of the dynamics of political public spheres and processes of (de-)regulation with special emphasis on instruments to tackle them both theoretically and methodologically.

Multidisciplinary Nordic Symposium

Nordic House, Reykjavík, Iceland

May 4-5 2015

This Nordic Symposium will bring together a multidisciplinary group of experts including administrators, academics and students as well as stakeholders working in the field, to discuss the role of local social services in times of disaster. The Nordic countries are known for their extensive welfare systems and the importance of local social services in providing universal care to all members of the public. The aim of the Symposium is to discuss the roles of local social services in preparedness, emergency response and the aftermath of disasters and how social services can enhance the resilience of residents and communities under such circumstances.

Organisers: The symposium is co-organised by the Nordic Welfare Watch – in Response to Crisis (NWW) and the Nordic Centre of Excellence on Resilience and Societal Security (NORDRESS) with support from the Ministry of Welfare in Iceland.

NORDRESS has received a 5-year grant from NordForsk to carry out multidisciplinary studies to enhance societal security and resilience. Partners from 15 institutions in all Nordic countries will join forces to elucidate the nature and importance of resilience of individuals, communities, infrastructure and institutions. Training and mobility play a significant role in NORDRESS that will e.g. support courses and seminars through the Nordic Societal Security Academy.

The project Nordic Welfare Watch - in Response to Crisis is a 3-year research project financed by the Nordic Council of Ministers. The project examines the role of local social services in times of disasters and the need for a Nordic welfare watch.

Food & cancer. Construction of a new social issue?

Food & cancer, construction of a new social issue?

This call aims examining the social and political construction of an emerging health issue, through established links between food and different kinds of cancer. This social issue is itself structured by an expanding scientific field that includes norms and ideologies of public health as well as new eating behaviors. Given the numerous social, economic, cultural and individual consequences, we invite contributors to this issue to consider the possibility that we are witnessing a new social issue in the making.

For the past thirty years, the study of links between food, nutrition and cancer has been the focus of numerous epidemiological, nutritional and medical surveys (see in particular De Thé and Hubert, 1988; WCRF and AICR, 2007). Today the subject mobilizes exceptionally active scientific networks at the international as well as national levels (see especially in France the Réseau National Alimentation Cancer Recherche -NACRe). Such study concerns both the multiple impacts of cancer and anticancer treatments on food behaviors and the role of food in relation to the development of the disease. Such surveys stimulate consensus groups and conferences on an international scale and contribute to a public health policy that is at once globalized and specific to each country (for France, cf. in particular INCA, 2009). Considering links between food and various kinds of cancer therefore indicates not only the emergence of a medical or public health issue, but also a real societal issue including multiple ramifications in social practice, both among patients suffering from cancer and in the general population.

That is why the influence of food (broadly speaking drinks, food supplements and herbal preparations, etc.) on cancer is, from this point of view, constructed Food & cancer. Construction of a new social issue? http://aof.revues.org/7732#tocto1n2 scientifically as much as a risk factor as a protective (Hubert, 1991), even healing, agent. More generally, the relationship between food and cancer refers to an ambivalent view of food perceived sometimes as noxious, sometimes as beneficial. This is actually reminiscent of the classic anthropological opposition between food perceived as poison or as remedy, or the opposition healthy / unhealthy (Vigarello, 1999) to be found in representations and ordinary practices as well as in unconventional conceptions (Cohen and Legrand, 2011). While cancer can be considered as one of the major diseases of civilization, conceptions of cancer prevention through diet tend to resolve not only the disorder of uncontrolled body cells but also disorders of society and food practices considered improper. From a medical or public health question, food turns into a lever of transformation in food habits. Therefore, links between food and cancer raise many problematic issues in the fields of epidemiology and the medical sciences as well as the human and social sciences. This conjunction and questioning is what we wish to highlight in this issue.

To what extent do scientific knowledge and the ambivalence toward food pervade not only the food practices of patients and their families but also the care and nutritional advice delivered by medical and paramedical teams, and more generally the food habits of society as a whole?

We propose a focus on the links between food and cancer in order to determine if we are, indeed, confronting a new societal issue in the making. We invite authors to reflect on the following topics.

1- Food as factor of risk and prevention: a scientific, socio-cultural and political construction

We wish to question the ways in which scientific knowledge is constructed over time and how it influences public health and scholarly conceptions of food. Historical or socio-historical approaches could be proposed to understand this emergence. Then too, the understanding of current processes could benefit from examining the roles of the principal actors (scientists, biologists, physicians, epidemiologists, nutritionists, oncologists, etc.), contexts and institutions which take part in the

construction of this public health issue. Analyses of the construction of this thematic scientific field would, possibly allow identification of "arenas" of discussions, exchanges and controversies (cf. on obesity Poulain, 2009). In the same way, the process of agenda setting for public policy and public health would be a fruitful site for examination.

The following themes could be approached:

- Construction of scientific knowledge and the modalities of influence on public health (between science and policy): historic and socio-historic perspectives
- Construction of conventional and/or expert knowledge and its influence on practices and associational, community and political practice.
- Parallel construction of non-conventional concepts, in addition or even in reaction to conventional ideas.

2- Food and the cancer experience

For cancer patients, food before, during or after cancer is an inescapable topic of "the stages of cancer" (Ménoret, 1999). Indeed, the experience and treatment of cancer often involve food changes, even problems (Locher et al., 2009; Hoarau et al., 2012; Fontas et al., 2014; Lorcy, 2014), which are even worse for older patients. Depending on the different countries and care centers, ordinary care management can be offered in order to limit risks of malnutrition and infection and to better assist patients in everyday life. However, nutritional management in cancer may malfunction and not meet the expectations and needs of patients (Bell et al., 2009). Such malfunction can prompt the use of unconventional practices that involve alternative authorities (Cohen & Legrand, 2011). We aim here to bring together scientific knowledge and public health concerns with the experience of cancer by patients, their families and caregivers.

Various elements can be considered:

-The impact of public health recommendations, popularization of scientific knowledge about patients' food habits.

-The real-life experience of patients: difficult food changes, sensory alterations, managing everyday life (food supply, meals preparation, social life, etc.)

-Conventional and unconventional care of problems and/or food changes induced by cancer and/or treatment of side effects, the relationship between the treatment proposed and public health recommendations

-The caregivers: management of chronic illness and impact on everyday life and food practices.

3- Cancer as producer of food reform(s)?

We also want to consider more generally how society and its various components have used scientific knowledge or/and representations of relations between food and cancer (Bell, 2010). Cancer has now become a major cause of morbidity. Observing the preponderance of medicalization and health in contemporary societies in addition to a moral economy (Fassin, 2009; Fassin and Eideliman, 2012) that is oriented towards a quest for health or the legitimization of social issues through health, we suggest examining the fight against cancer through food as a significant "food reform" under construction.

Thus, what is the impact of scientific knowledge and public policy on the prevention of cancers in the general diet? How do individuals take control of reforms instigated by public health agencies and governments? Areas that might be explored include:

- Definitions and modalities of appropriation of "food reform" (according to geographical units and countries)
- Vectors of food reform: circuits of production, distribution and consumption including advertising and marketing strategies, as influenced by "the will" of the dominant food reform

- Production of a new food culture: changes in food practices and cultures, construction of a new food morality, mobilization of values centered on health
- Limits of promoted food reform: divergent food reform messages, pernicious effects, role of food values and food representations unrelated to health, product accessibility, production of social inequalities, etc.

We invite potential contributors to share their work that may involve differentsocio-cultural contexts in various parts of the world. Contributions may be in English, French or Spanish.

Deadlines

Paper proposals should be sent before **March 20th, 2015** at the latest and should include an abstract of 12 lines maximum accompanied by a maximum of 10 keywords. Proposals should present the title of the article, research question, the field studied, the methodology and the main results obtained. They should also include name, first name, status, institutional affiliation and e-mail of the author or co-authors.
