### Call for Papers Sociology of Childhood – Theorising Childhood: Citizenship, Rights, Participation

The Research Network, Sociology of Children and Childhood hereby announces the mid-term symposium which will take place inModena (Italy) from 21<sup>st</sup> to 23<sup>rd</sup> May, 2014. The organisation of the symposium will be undertaken at the University of Modena and Reggio Emilia.

The focus of the symposium will be on **theorising childhood**, in particular the areas of citizenship, rights and participation, exploring the different and various perspectives that can include these topics in the broader field of childhood studies and Sociology.

This symposium follows, continues and articulates the ideas developed during the symposium in Jyväskylä (Finland) in 2012. The objective of this symposium is to invite theorising in the wide variety of contexts of citizenship, rights and participation, approaching the social studies of childhood in terms of children's actions, children's competences and children's viewpoints and perspectives.

The first day of the symposium (21<sup>st</sup> of May) will be dedicated to a public conference, with the participation of the following keynote speakers:

Hanne Warming (University of Roskilde, Denmark), on children's global citizenship Karl Hanson (Kurt Bösch Institute, Sion), on children's rights
Michal Wyness(University of Warwick) on children's participation
Maria Herczog(chair at Family, Child and Youth, Reader at EszterházyKároly College, member of the UN CRC Committee) on promotion of children's rights and participation

The second and third days of the symposium will be dedicated to paper sessions. Although the focus of the first day of the symposium is around theorising childhood citizenship, rights and participation, the call general Call for Papers is **open tocore theoretical areas of the sociology of childhood**.

We therefore invite experienced and young researchers from various disciplines sensitive to the sociology of childhood to participate. Although presentations and discussions will mainly revolve around theorising, participants are welcome to discuss theoretical implications for interdisciplinary work on childhood. Presentations can be related to the following areas:

- 1. Classical sociological theories and new directions in sociological theories of childhood
- 2. The concepts of temporality and spatiality in theorising childhood
- 3. Theorisations of cultural identity and (global) citizenship applied to children
- 4. Theories of rights, inequalities and injustices in childhood
- 5. Theories of children's participation in institutional and informal contexts
- 6. Theorisations around gender and ethnicity applied to children
- 7. The role of theory in interdisciplinary work on childhood

There will be no conference fees. The number of delegates will be restricted to 30 to enable discussion. The papers will be selected according to relevance to the areas of the symposium.

The abstracts must be written in English in no more than 400 words, and include 3-5 keywords. The Research Network "Sociology of families and intimate lives" (RN13) of the European Sociological Association (ESA) invites you to the Interim Meeting "Family: continuity and change" to be held in Vilnius, Lithuania, on 25-27 September, 2014.

Numerous sociological studies conducted during the last decades have revealed an increased diversity and de-standardization of family forms and configurations, family formation patterns and interrelations among its members. These changes are so evident and dramatic, that occasionally even the question has been raised whether family as a social institution still exists. Until today in many European countries we observe ongoing trends, e.g. of decreasing marriage and / or birth rates, of increasing divorces and remarriages, of postponement of family formation to later stages in the life course.

At the same time researchers observe continuity and, especially in Northern Europe, even trends' reversals. Traditional patterns of the division of paid and unpaid work within couples, for example, are visible everywhere, even if on gradually more subtle levels. The desire to live in a stable partnership and the motivation to have children remain high. The family still is considered one of the most important values and life spheres.

Continuity and change – we find both at the same time. So, questions arise: how much continuity do we observe? Where do we observe change and why? How can the observed change / continuity be explained at a global, social group or individual level? How can we explain asynchrony of developments between the European countries / regions? How can and should we identify and measure the change / continuity? Are we over- or under- estimating the degree of change due to a lack of appropriate methods?

The organizers of the Interim Meeting 2014 "Family: continuity and change" invite you to submit abstracts focusing on one of the following issues:

- . Theoretical concepts in studying families
- . Family value as an institution
- . Family forms and configurations
- . Structure and/or functions of family social networks
- . Roles and biographies
- . Family research methods

A special PhD session will be held at the meeting. The best PhD paper will be awarded by the prize.

#### Each proposal should include:

- A. Title of the paper
- B. First name and surname of author(s), email, institutional affiliation.
- C. Extended summary of the content (1500 words), including:
  - 1. a description of the theoretical framework
  - 2. the research hypotheses
  - 3. a description of the data and the research methods
  - 4. most important findings
  - 5. conclusions / discussion
  - 6. list of references (10 maximum)
- D. Keywords: up to five keywords describing the main contributions of the paper.
- E. PhD students should additionally indicate in the abstract: (1) the relevance of the issue discussed; (2) the stage of the research carried out.

All abstracts should be completed in English. Individuals may submit a maximum of two abstracts but should not be the first author of more than one paper.

Each paper will be given 30 minutes (20 minutes for presentations, 10 minutes for discussion). Parallel sessions will not be conducted therefore maximum 30 papers for oral presentation and 8 papers of PhD students will be accepted for the conference.

The papers will be selected after a reviewing process. Accepted papers exceeding the scheduled number of oral presentations will have the opportunity to be displayed as a poster.

#### Call for papers - Mid-term Conference | Religion in the Public Domain

In long-standing theories about secularization it is generally held that the social and public significance of religion has declined in most Western countries. Religion is conceived as privatized, individualized and de-institutionalized. But has religion truly become a privatized phenomenon? Increasingly, it is argued in academia that the separation between state and church in Western countries is less stable than assumed: state policy is often biased towards particular religious traditions while even the French installment of laicité may be understood as a civic religion (e.g., Casanova). In general, we are witnessing a re-emergence of religion in the public domain. Religion has a new position in the public sphere, struggling for recognition alongside other groups. Empirical studies demonstrate the sustaining influence of religion on voting in 'secular' countries, an open attitude towards religiousspiritual beliefs and practices in business organizations and the production and consumption of religious symbols and images in popular culture. The role of media is pivotal here: it has made new forms of power emerge, but also simultaneously opened the way for activist practices aimed at visibility. So on the one hand, television, radio and newspapers socially construct the public-political discourse on Muslims, the alleged dangers of Islam and religious-ethical issues concerning circumcision, vaccinations, abortion and ritual slaughter. On the other hand, in the struggle for recognition and visibility, Christians, Muslims, Buddhists, Hinduists, new religious movements, and spiritual groups, appropriate the internet and (social) media as public platforms to debate the role of religion, to strengthen social cohesion and to reach out to the general public.

This return of religion in the public domain is also a socially, politically, legally and morally contested issue. In a 'post-secular' society, Jurgen Habermas argued, religious groups, organizations and individuals should be included within the public sphere in the civic debate about the problems of modernity, i.e., individualism, excessive consumption and the loss of moral values. Claims like these – made in academia, politics or culture – activate secular groups like the 'new atheists' to revitalize 'rationalist' values of the Enlightenment and take on a fundamentalist position on the subject. Social conflicts are increasingly religious conflicts (e.g., Calhoun). Theoretically, developments such as these invoke substantial doubt about modern distinctions between the public and the private, the secular and religious and the profane and the sacred. They invite research on the (historical) formation of such categories – in the social sciences and modern cultures alike – and its relation to social conflict and cultural power (e.g., Assad).

Against this background, the ESA Research Network Sociology of Religion calls for papers on 'Religion in the Public Domain' for the mid-term conference in Belfast. Particularly papers are welcomed that discuss the following topics:

- Studies focusing on the modern separation of state and church, the formation of the religious and the secular and the public and the private domain in European countries and beyond.
- Studies discussing the social significance of religion and its re-emergence in the institutional and public domain, i.e., the role of Islamic, Christian or spiritual beliefs, practices and experiences in politics, voting, banking, business life etc.
- Studies focusing on the role of religious-spiritual narratives in popular culture, i.e., their meanings, commercial and commodified manifestations in books, music, film, computer games, advertising, marketing and branding.
- Studies discussing the role of the media, i.e., the way religion is framed at television, radio and in newspapers, and the appropriation and use of (social) media by religious individuals, groups and organization
- Studies focusing on social conflicts between secular and religious groups and public debates about Islam, i.e., about integration, religious fundamentalism, terrorism, women's rights, headscarves, abortion etc.
- Studies focusing on the public value of the sociology of religion, including studies on religion and politics, religion and the welfare state, religion and human security in 'failed' states, and the significance of the study of religion to policy makers and grassroots activists.

These topics are rough guidelines; papers dealing with Religion in the Public Domain beyond other

than these outlined above are also very welcome. Furthermore we invite PhD and post-doc candidates to contribute to a poster session, including work in progress; the best poster will get a small, but nice prize.

CONTESTED MIGRATION REGIMES: EUROPEAN PERSPECTIVES AND BEYOND MID-TERM CONFERENCE of the ESA RESEARCH NETWORK 35 "Sociology of Migration" 13<sup>th</sup> and 14<sup>th</sup> November 2014, Frankfurt am Main

After organising successful sessions at the 11<sup>th</sup> ESA Conference in Torino, the Research Network 35 "Sociology of Migration" is now announcing its second mid-term conference, to be held from 13 to 14 November 2014 at Goethe University Frankfurt. Our aim is to provide a platform for those who have already met at earlier conferences to continue our discussions, and to invite other scholars to join us in this endeavour. Thematically, this conference will bring together various sociological approaches to the political regulation of migration and mobility such as the emergence of (European) migration regimes over the past decades, the discourses and practices involved, the social and cultural contexts of political regulation and the impact of migration regimes on migrants' lives and practices. Abstracts can be submitted to esa.migration@yahoo.com by 1<sup>st</sup> April 2014 (please see below for details).

#### Theme of the conference

The media debates on Islamophobia and the electoral success of the far right, current refugee movements throughout Europe and recurring protests against FRONTEX are recent examples of the controversial character of migration politics in Europe. The concept of 'migration regime' provides a

helpful framework to address the contested and complex dynamics of current migration politics from a sociological perspective. It allows us to explore the interplay of political decision making, established legal frameworks, dominant discourses of belonging and institutional configurations in the political regulation of migration. Migration regimes can thus be seen as specific assemblages of institutions, political actors, legal regulations and discourses which structure social practices of geographic mobility and individual decision making.

Starting from the concept of migration regimes, our midterm conference will cover five broad issue areas:

- 1. Sociological diagnoses of current changes: How do sociologists assess recent changes in migration regimes and recently established political instruments such as citizenship tests and increasingly detailed immigration statistics? Are we, for example, witnessing a renaissance of guest worker regimes and the end of 'securitised' migration politics? What is the (future) role of the nation state and how far developed is the transnationalisation of migration regimes? How are the national and the supranational scales intertwined with regard to the regulation of migration? Are we witnessing the emergence of qualitatively new forms of transnational or postnational regulation in the EU context as well as in other regions of the world? How are current migration regimes linked to racialised and gendered knowledge?
- **2. Political institutions and practices involved in the regulation of migration:** Who are the main actors involved in the regulation of migration (political authorities, commercial companies, NGOs, protest movements, etc.)? How do different forms (state and non-state) and levels of governance (the local, national, regional, and global) play together in the regulation of migration and mobility? What role do experts (within and beyond academia) play in this regard? What role do practices and discourses in other professional fields such as media and education play for the regulation of migration and citizenship?
- 3. Effects on migrants' lives and practices and 'evaluation' of policies from below: In what ways are mobile individuals, families, communities and diasporas affected by migration regimes? By what means or by what 'political technologies' are mobile individuals' migration practices channelled? How do individuals navigate through the complex formal and informal arrangements? What strategies of resistance do they use and develop?
- **4. Links to politico-economic transformations:** How are changes in the political regulation of migration linked to broader societal transformations such as the rise of neoliberalism, new industrial relations and the ongoing economic crisis? How do these societal shifts impact migration regimes? And, how do these regimes emerge on the global, transnational, national and city scales?
- <u>5. Sociological self-reflection</u>: What implications do scientific accounts of political developments have for future research practices? What (unintended) role do sociologists play in the (re-)production of migration regimes? How can sociologists remain relevant without becoming part of the very system they criticise?

We encourage contributions on theoretical, empirical and methodological issues. Studies involving longitudinal and/or comparative analyses and contributions focusing on the European context are particularly welcome, as are papers which analyse everyday practices and strategies of action and resistance of migrants and their families.

#### Higher education, mobility and migration in and out of Africa

Date: Thursday, June 19 -. Saturday, June 21, 2014

Higher education is a central element to foster socio-economic development. It helps young people by providing them with professional qualifications, to establish themselves occupationally, and enabling them to become mobile in social and geographical terms. These issues are particularly important in Africa which is the only macro-region in the South where per capita income has declined over the last years, despite some economic growth, because of extremely high birth rates. African governments recognize the importance of education for socio-economic development and increasingly invest also in higher education. The rapid expansion of universities, especially of private institutions, however, now is increasingly difficult because of the shortage of university teachers. As a consequence, the quality of education might suffer. Also the employment of university graduates is a problem given the weak development of modern industrial and service sectors. Closely related to this is the issue of emigration of graduates (brain drain) toward Europe and America. The conference shall discuss all relevant issues concerning the development, quality, and outcomes of higher education and university teaching and research in Africa from a comparative perspective, with a specific focus on relations between Africa and Europe. Furthermore, the conference shall provide a forum for both African and European social scientists in order to exchange relevant research findings across continents.

- Race, the Environment, and Sustainability

Note that any of these could also be roundtables, which serve to promote discussion and sharing ideas a bit more than traditional paper sessions.

You are welcome to submit papers regarding any of these topics, or on a topic relating to your own research. If you would be interested in putting together an entire session, let us know and we would be happy to provide you with details as to how to do this.
