While Research Networks anchor in specific fields of sociology, Research Streams offer the chance to focus more specifically on our conference theme as well as on new themes across the boundaries of the sociological subdisciplines. Some RS will continue their work from previous conferences; others will introduce new ideas to the conference programme.

CIVIL SOCIETY ORGANIZATIONS IN THE MEDITERRANEAN AREA: SOCIETAL ROLE, CHALLENGES, DYNAMICS

The intensification of the financial, social, economic and political world crisis, the weakness of welfare systems and their difficulties in providing adequate answers to growing risks of social exclusion, urges sociologists to develop adequate reflection and empirical data on social inclusion policies.

The capitalist worldwide regulation system is presently facing a severe test, not only as to state budgets stability or growth of economic investments and monetary stability, but also as to the very possibility of maintaining adequate levels of social protection and social cohesion.

Social cohesion is necessary in order to find ways of mediation, conflict regulation, compensation, and solutions proposal. The relevant actors for social cohesion are still people and their communities. Inclusion policies can reinforce those actors by means of participation, by strengthening the relationship with the territory and its concrete needs. Real needs of people do not necessarily fully coincide with formalized rights. In times of economicistic managerialization and financial redefinition of welfare systems, those needs are more and more subject to limitations, constraints, restraints, deferrals, denials.

The need for social cohesion is to be investigated in relation to participated public policies, opened to non-profit initiatives and targeted to support civil society actors.

Civil society and its organized expressions claim for more discussion and debate opportunities. Thus, initiatives that promote new forms of participation are increasing, especially referring to the principles of horizontal subsidiarity. This increase of the "participatory offer" is without doubt a positive thing. But literature points out that it is not without risks. Literature also highlights the fact that participatory practices can take many forms and pursue different outcomes.

The White Paper on Governance of the European Commission states that "the linear model, whereby policies are adopted and imposed from above, must be replaced with a virtuous circle, based on feedback, networks and involvement at all levels, from policy to implementation".

The promotion of participation practices and policies within member states by the EU is pursued by means of several measures and actions aimed at involving individuals and organized forms of civil society into the decision-making processes. More recently, the EU has sought to extend such policies to neighboring countries. That idea has not met unanimous consensus, whereas many have perceived it as an expansion strategy of the EU market.

A peculiar critical role was played by the associations that have joined the "Civic Caravan" project launched in Morocco in 1997. The interest of that initiative is that it takes the form of a "concerted action" among Mediterranean civil societies' organizations aimed at developing projects that can be respectful of different cultural identities, of national sovereignty and aimed at solving real problems in the Mediterranean area. Other considerable examples in that sense are the Réseau European des droits de l'Homme Méditerranéen and the EuroMed Non-Governmental Platform, where many European, North African and Middle Eastern associations are represented.

Those initiatives testify the significant degree of maturity already achieved by the various organized expressions of civil society in the Euro-Mediterranean area, as well as their ability in developing connections to pursue forms of action that are not limited to a local or national dimension.

For nearly a decade now, South Mediterranean civil societies have been undergoing a remarkable dynamism: the number of associations has increased tenfold, and so did the number of members and, more generally, of activists. Faced with the exponential growth of the phenomenon, governments of North African and Middle Eastern countries have adopted different strategies. On the Northern bank of the Mediterranean as well, significant developments of civic organizations are observed.

Forms and purposes of Civil Society Organizations active within the different Mediterranean countries vary significantly and are only partially overlapping. A more detailed empirical analysis is needed to gather useful information for comparison and provide a descriptive picture of the overall situation in the Euro-Mediterranean area.

The associative experience in this part of the contemporary world is very diversified and lively. Therefore, an in depth confrontation is needed within the sociological community, in order to reach a better understanding of the dynamics of Civil Society Organizations in the Southern European Countries, as well as in the whole Mediterranean area.

The main purpose of this mid-term conference will be to explore the societal role, main challenges and dynamics of Civil Societies in Southern European countries, and in the Mediterranean area at large. Theoretical as well as empirical presentations are welcome, both referring at national experiences and international comparisons. Specifically, papers, power-point presentations and works in progress are invited on the following topics:

- 1. Active citizenship
- 2. Societal needs and welfare systems and Civil Society Organizations
- 3. Local, national and international networks of Civil Society Organizations
- 4. Civil Society Organizations and other forms of societal and political activism
- 5. The economic relevance and role of Civil Society Organizations
- 6. Social protest, mobilization and Civil Society Organizations
- 7. Organizational forms and dynamics of Civil Societies
- 8. Social and political participation
- 9. Civil Society Organizations and sociological research: possible collaborations

Abstract -Paper Format and Language. The organizers invite theoretically or empirically grounded papers on the above (or related) topics. Special consideration will be given to empirically grounded papers, either comparative or country-based. The language of the abstracts, the papers and the conference will be in English or French. Abstracts should be about 500 words, and should be accompanied by the name(s) of the author(s), his/her/their affiliation(s) and E-mail(s).

Individuals may not participate as senior authors in more than one session. Abstracts should be submitted to Andrea Vargiu (larvanet@tin.it) and Ana Romão (anaromao74@gmail.com), by **August 15th 2012**. Upon receipt, they will be sent to members of the scientific committee for review. Depending on the final structure of the conference and contents of papers, the scientific committee will eventually decide whether to assign proposals to oral presentations or poster presentations. Participants will be notified regarding acceptance the latest on **August 30th 2012**.

Those whose abstracts are accepted are urged to submit their completed papers by September 15th 2012.

Conference Fees:

ESA non-members: 100 Euros for non-students and 50 Euros for students.

ESA members: 60 Euros for non-students and 20 Euros for students.

The fees will cover organization costs and conference material for participants (conference bag with abstracts book and conference program) as well as coffee breaks.

Paper presenters and conferees are expected to register by September 15th 2012, at the latest.

International ChoreoLab Austria (ICLA): LAND.body.scape_corpography

Art-based research in the interface of body, mind & nature in St. Margarethen/Burgenland, in Austria

August, 27th - September, 2nd 2012

As a new transdisciplinary artistic field work in nature this ChoreoLab combines performative training, lecture, demonstration & discussion with experts from the fields of choreography/dance, body-mind techniques, architecture, land art & botany.

Performers and interested protagonists from other fields are invited to the collective unfolding of creative potential in a communicative forum taking place at the art and nature sanctuary of St. Margarethen.

Corpography

As "dance of things" LAND.body.scape_corpography mediates between the internal and external bodily spaces and provides a redefinition of modalities, investigating the living environment through the body. Corpography implies a critical process of reflection and inquiry on anthropological and socio-cultural transformations of both the individual and society. At the same time it provokes wide-ranging questions about body and environment as a complex system in constant evolution.

The focus of this corpo-topographical research lies in the exploration of surface textures/patterns, not as inanimate matter, but as vital interfaces of relationships, determined by their innate characteristics such as proximity/distance, porosity, mimicry, weight, flexibility, fullness/emptiness. In this specific format combining theory and practice, contemplation and realisation, elementary interrelations such as shape and scape, mass and fragility, motion and emotion, action and inaction will be investigated through gardening and bodywork.

International ChoreoLab Austria

The International ChoreoLab Austria (ICLA), initiated by the choreographer Sebastian Prantl and pianist Cecilia Li (directors of Tanz Atelier Wien) in 2009, provides continuous art-based research in the context of performance studies. The focus is based on an interdisciplinary discourse through an expanded concept of choreography.

After a three-year successful cooperation with Danube University Krems, this extraordinary, sitespecific ChoreoLab is taking place in conjunction with the distinguished organisation Symposion of Europaen Sculptors at their headquarter within the art and nature sanctuary of St. Margarethen/Burgenland in Austria.

Art & Nature Sanctuary in St. Margarethen

The sculpture symposium movement was founded by the international renowned sculptor Karl Prantl (1923 – 2010). While working in the stone quarry of St. Margarethen, Karl Prantl underwent the experience that sculptures are determined by other factors and influences out in the open than they are in a closed room. This led in 1959 to the foundation of the first "Symposion Europäischer Bildhauer" (Symposium of European Sculptors) which was held annually with a working group of up to 15 sculptors over a period of two to three months.

In the following years a unique cultural stronghold has been growing at the hill of St. Margarethen, harbouring exemplary land art positions, which through the ChoreoLab will once again be the starting point for a new initiative of collective artistic enterprises.

Target Group

Empowerment, compassion and deep understanding through shared experience characterize the activities of the ChoreoLab since 2009 and provide a distinct label within the multitude of international interdisciplinary education programs. This new strand of a creative team work format has attracted experts of all professional fields, ages and cultures.

The target group includes protagonists from various fields such as the arts, architecture, humanities, social sciences, (new)media, pedagogy and environmental studies.

VIIth International Cultural Studies Symposium – Memory and Culture

The 7th Cultural Studies Symposium on Memory and Culture jointly organized by the Turkish Cultural Studies Association and Bilkent University, Department of Political Science and Department of Architecture, will be held on September 5-7, 2013 in Ankara, Turkey. The International Cultural Studies Symposia that are organized every two years have been contributing to cultural studies and bringing together researchers who work in this area. Since the first meeting in Kemer, Antalya (2001), the Symposia have been organized, jointly, in Van with Yuzuncu Yil University (2003), in Istanbul with Koç University (2005), in Şile with Isik University (2007), in Zonguldak with Karaelmas University (2009), in İstanbul with Kadir Has University (2011).

The purpose of this symposium is to question existing paradigms in topics that bring together the concepts of "memory" and "culture"; it aims to present critical and analytical approaches and to explore new theoretical and methodological paradigms in cultural studies. It adopts an inter- and multidisciplinary perspective that includes such disciplines as sociology, anthropology, psychology, political science, urban studies, architecture, design, and literature; it also takes a gender perspective. It should relate to issues about Turkey and Turkish cultures. Submissions, both domestic and international, are invited on the following sub-themes.

The conference is open to a variety of themes beyond the suggested ones as long as they deal with memory and culture.

Memory is about the retreat to consciousness of experiences, accompanied by awareness that it has happened somewhere sometime. Culture is its concrete form; the term goes beyond its everyday connotation with art, civilization and development; it is used in the anthropological sense referring to a "way of life."

The relationship between memory and identity is an important one. The way the individual remembers his/her own or family's past determines to a significant degree what s/he is. This is "discovering" oneself in a particular way.

The relationship between memory and space is also important. We remember everything with its location in space. But this can happen only in relation to social frameworks, as M. Halbwachs puts it. Social frameworks can be broadly classified as the family, religious / ethnic groups and social classes. They are the instruments used to reconstruct an image of the past which is in accord with the dominant ideas of the society in a particular epoch. Therefore, memory is selective.

Memory is also a question of social and political power. What we remember depends upon the context and the group(s) that we are part of.

Accordingly, the depth and contour of our collective memory reflect also the competitive positions of power groups. Political power usually has the tendency of reconstructing collective memory to reproduce its legitimacy.

Today the interest in the past and consequently in the collective memory has intensified. In the processes of globalization, ethnic groups' claims of recognition in post-modern societies have brought the need for ethnic groups to construct their past and hence their collective memory. The collective memory written during the construction of the nation state as a political project is today questioned and challenged; and the past, which is forgotten or rendered forgotten, is today brought to public attention, creating awareness about new collective identities. This once again turns collective memory into a political project, this time of ethnic groups.

As migration movements increase in our globalizing world, migrants tend to construct their identities in their new societies using their constructed collective memory, thus ending up keeping their identities based on their places of origin, i.e., not forgetting who they originally are.

The fact that cities have become important means of accumulation of capital in the neoliberal economy has sharpened the competition among cities to attract investment and tourism; and in the endeavor to create unique identities for the cities, the concepts of cultural heritage and nostalgia have gained much popularity. Thus, cities turn into sites of consumption as their pasts are constructed in particular ways to create special city images and identities. Moreover, the increased environmental problems render important the collective memory constructed about the issues of nature and disaster.

In the framework given above, the sub-titles about Memory and Culture can be as the following, which can be differentiated according to personal, group and social memory:

Identity and memory (Family and memory; Biographical and autobiographical studies; Migration, diaspora and memory);

Space and memory (Memory and culture in architecture; City, urbanization and memory; Gecekondu (squatter housing), village, city, neighborhood, nature in collective memory);

Politics, political power and memory (Memory and culture in modernity / modernization/ modernism; Construction of memory as a political project; Nationalism and memory; Ethnic identity and memory; Minorities and memory; Political trauma and memory);

Memory and culture in everyday life (Traditions, memory and culture; Rituals, memory and culture; Bodily practices, memory and culture; Recreation, memory and culture; Disasters and memory; Nostalgia and memory);

Social institutions / Cultural products and memory (Art/Literature, memory and culture; Language, memory and culture; Religion, memory and culture; Media and memory; Internet and virtual memory);

Proposals to be submitted for the Symposium may be in the form of (a) individual paper presentations, (b) pre-organized panels consisting of 3 to 4 individual presentations, (c) poster sessions, and (d) exhibitions.

Abstracts of individual papers should be submitted not to exceed 200 words, written in Times Roman 12-point font, single spaced. Also expected are five keywords, as well as a short CV and contact

Social research relies on our claims of understanding people – which often rely, further, on the claims advanced by our research participants (as respondents, informants, subjects, or in other roles) of understanding themselves and other people.

At times, we are also confronted, as researchers and in other walks of life, with difficulties, failures, and outright impossibilities of understanding people.

We invite papers that reflect on forms of understanding, misunderstanding and not understanding people. Articles that have a comparative focus, by looking at different forms, instances, settings etc., are especially welcome.

Some of the questions that may guide discussion include (without being limited to) the following:

- *Different forms*: What forms and claims of understanding, not understanding, misunderstanding, uncertain understanding, better understanding etc. **have we encountered** in our research?

How do we position our understanding to be better? How do we elicit their understanding?

- *Techniques and technologies*: How do we operate with theories, schemes and models, methods, techniques, instruments of understanding people? How do other people operate with such **tools**? What do we (and others) take to be more or less reliable **indicators** of other people's thoughts, personalities, motives, ways of being? How do we elicit and / or read CVs, photos, Facebook profiles, test results, biographies, obituaries, interviews, and other would-be ways of understanding people?

- *Different perspectives*: How do different theoretical or disciplinary perspectives shape our understanding of people? What are the benefits and the threats of drawing on, and combining, different **disciplinary perspectives** in our research papers/studies?

Articles that engage in a comparative approach, connecting different concepts, materials, methods, situations, pieces of research or other social realities, are particularly welcome. Applications are now opened. The deadline to apply for the 2013 Summer School is August, 30, 2012.

The goal of this program is to provide scholars of the social sciences with access to high-quality, cutting edge, advanced training in qualitative and quantitative social science methods. The target group is high-potential, upper-level scholars of political science, international relations, and related disciplines. Preference will be given to current faculty members, post-doctoral and doctoral students. Truly exceptional masters' students in political science, international relations, and closely related fields will also be considered.

Academic objectives:

This program aims to provide basic training in three general areas:

- 1. quantitative data analysis,
- 2. qualitative data analysis, and
- 3. research design and methods.

It is hoped that participants will be able to return to their home institutions with greatly enhanced methodological skills, having built bridges with peers from other institutions and nations, and with the potential to disseminate these skills effectively among their peers.

We seek a varied student body, with representation from as many countries and methodological backgrounds as possible. Our three first Summer Schools, held in February 2010, 2011 and 2012, brought together students from 10, 16 and 15 different countries, respectively. One-fifth of the students were current faculty members, and half were doctoral students. In the 2012 season, the School received 133 students.

Applicants must submit their applications by August, 30, 2012.

Applicants will receive a response to their applications by September 15th. To confirm course enrollment, applicants must pay the registration fee. A copy of the bank deposit or receipt will need to be uploaded to the online system before October 15th. For those students who do not pay the registration fee on a timely basis, slots will be allocated to those applicants on the wait list.

Classes will be held full-time between January 21 and February 8, 2012 on week days. Given the extreme rigor of the coursework, which will be taught in English, each accepted applicant will be permitted to enroll in only one course (or two one-week courses). Students who successfully complete the coursework will receive a course certificate and an evaluation of their performance will be sent to their home institution.
