#### Second Annual Conference of the Balkan Sociological Forum Close but Unknown Neighbors : Balkan Sociological Perspectives 9-10 November 2012

#### Sofia, Bulgaria

The Conference is organized by the Balkan Sociological Forum and Bulgarian Sociological Association and supported by the International Sociological Association. It will be held parallel with the XIII Congress of the Bulgarian Sociological Association on November 9-10, 2012 in Sofia.

#### A. Place of the topic in relation to state-of-the-art in sociology

The Balkans have been systematically studied by historians, anthropologists, cultural studies experts, art historians, but have rarely been placed in a general sociological perspective. Comparative studies on separate social problems have rarely included more than three or four countries. In fact, from a sociological perspective, Balkan countries pose a double challenge: social and cognitive.

There is the social aspect, for even though they have a shared past of authoritarian and totalitarian regimes in different periods of the 20<sup>th</sup> century, their social and political development in post WW2 Europe has not been the same for all countries. Their common present situation of transition to a market economy and democratic structures like those of Western Europe, does not cancel the specific ordeals of economic, political, and social development that each national society of the Balkans is going through. Engrossed as we are in the supra-national structures of the EU and of Transatlantic cooperation, we hardly notice our neighbours; moreover, we fail to realize that the position of each country on the international scene depends on its relations with, and the support of, its closest environment. In competing for international recognition, our interest in neighbouring countries is all too often limited to what can be advantageous though detrimental to them. Thus we miss the chance of working together to overcome our common weaknesses and achieve mutual consolidation of our separate advantages. In scrutinizing our own problems, we fail to look around us and see that, within the proximate region - so close to us by its historical destiny and present state of civilization, some country may have already found a solution to some of our own problems. What are our Balkan neighbours like as economic and political players, as stratified societies and united communities, as educational and cultural structures, as ways of living together and recognizing the other? What is happening here and now in each Balkan country? How does the past impact on the present in each country and in the relations between them? What part of the contemporary experience of each country could be useful for its neighbours, so that our presence in united Europe and in the world might be constructive, mutually enriching, and stimulating? These are all questions to which sociology, with its rich variety of paradigms and approaches, can provide well-argued and thoughtful answers.

As concerns the Balkans as a cognitive challenge, this aspect consists foremost in the problems that the current processes of internationalization and interdisciplinary scientific knowledge pose for sociology. The national communities of sociologists in Balkan countries compete to win a place in the European production of interdisciplinary and policy-oriented knowledge, but we are also partners playing non-hegemonic roles in the international research area. These combined features provide a suitable starting point for analysis, and our integration in the European Research Area clarifies a number of problems, such as:

- the marginalization of national sociological traditions;
- the neutralization of local issues by presenting them as Eastern equivalents of problems formulated with reference to the West European social and research context;
- the irrelevance of applying a theoretical framework to social situations in separate national contexts;
- the replacement of scientific argumentation as to the validity of knowledge by imperatives of immediate applicability;
- the tension between local vocation vs. international involvement; the growing dependence of the research structure and the type of knowledge produced relative to the forms of funding and the supra-national management of scientific production, etc.

# **B. Objectives and topics**

The main objective of the Second Annual Conference of BSF is **by identifying the common** and specific problems in the contemporary development of Balkan countries, to contribute to a better understanding of our own society, and to the development of sociology as a cognitive solution to the contextual problems, a solution based on adequate theoretical and methodological tools.

The discussions will be organized around the following thematic centers:

- The Contemporary Economic Crisis: Political Solutions, Technological Answers, Individual Strategies;
- Mobility and Social Inequalities;
- Global Social Order, States, Citizens;
- Transformations of Identities and Social Relationships in the Balkans;
- National Sociological Traditions and the Sociologist's Vocation Today.

# Addiction - What is the Added Value of the Concept Today?

Colloquium of the University of Helsinki Centre for Research on Addictions, Control and Governance (CEACG), and Thematic Meeting of the Kettil Bruun Society.

# Background

Addiction is a concept that has relatively recently – within two or three decades – become a common expression that covers no longer only traditional substance use but a wide and growing range of behaviours like gambling, gaming, internet use, even eating disorders, shopping, shoplifting, sexual behaviour and others. The increasingly widespread use has been observed in the public media, in expert discourses, in popular culture, in the world of commercials, and even in everyday talk. The concept of addiction is being introduced in the international classifications of diseases, and addiction is the topic of many research and prevention programmes today.

There is no consistent and commonly agreed neurobiological theory of addiction, although recent brain research has made great progress in identifying some of the mechanisms that make people behave in a way that they recognize as harmful and would rather want to stop. There are well known similarities in the brain functions concerning the satisfaction of very different types of desires, but nevertheless the evidence is far from convincing to prove that from a biological point of view harmful repetitious behaviours could be lumped together as a singular disorder.

The issue is further complicated when we account for cultural factors. Addiction can be said to be caused from culture in the sense that addicted behaviours are transformations of culturally modified desires. We do not call dependence on proper nutrition, clean air and water an addiction unless their object is a pleasure that results from cultural practices, like preparing food, raising endorphine levels by physical exercise, or getting intoxicated in one way or another.

A third complication arises from the fact that treating excessive behaviours as a syndrome of an underlying disorder individualises the problem and medicalises societal reactions to it. This is why public health experts were cautious of the concept "combined approach" when it was part of the World Health Organization discourse on drugs, tobacco and alcohol in the 1970s, while at the same time recognizing the need to include alcohol in the policy agenda on illicit drugs and psycho pharmaceuticals. Instead of paying attention to the supply side, policies framed as prevention of addictions focus on identifying high risk individuals and preventing their harmful behaviour.

Also the conditions of prevention and treatment are very different concerning different types of behaviour. Preventing obesity involves measures that are very different from those that arise in substance use prevention, for example. The most extensive body of research exists for alcohol and alcohol dependence. The next large research area will most likely *concern gaming, especially gambling*. In this developing area the lessons learned from alcohol studies are particularly relevant,

because we need new understanding of the pathways from non problem use to problems and addiction. Alcohol research experience is of great methodological and theoretical help in this area. Also the policy issues are relatively similar, with wide public and private economic interests involved in both the alcohol trade and in the gambling business. Moral and philosophical issues are also similar, concerning individual freedom of choice and the public good.

# Objective

The Colloquium and Thematic meeting provides a platform for discussing the usefulness of framing consumption risks as addictions, or even as different aspects of a singular phenomenon. Critical and careful analysis of evidence, reflexion on the moral and practical implications of the concept in different contexts, and the way forward need to be given a proper and free space of interchange between different points of view. It might be envisioned that some sort of consensus emerges that could be useful for policy makers, but this CFP is not foreseeing that as necessary.

#### Size and structure of the meeting

We aim to attract about 30 - 40 interested experts from several fields to participate and papers will be precirculated. We aim to keep the number of presentations moderate, hoping that participants will read as many papers as possible in advance of the occasion. Presentations will be organised in sessions of 1,5 hours with two or maximum three papers per session, chair and a discussant will be assigned to each session.

# Time and venue

The meeting will start on Sunday evening October 14th and last until dinner on Wednesday October 17th. The venue will be the Majvik Conference Hotel near Helsinki.

#### Call for Chapters - Advanced Methodologies for Communication Studies

Organizers: Rita Figueiras, Catholic University of Portugal Verónica Policarpo, Catholic University of Portugal

«There are times in life when the question of knowing if one can think differently than one thinks, and perceive differently than one sees, is absolutely necessary if one is to go on looking and reflecting at all .»

These lines of Michel Foucault, in his introduction to the second volume of his History of Sexuality, inspire the core concept of this Call for Chapters for a written volume on advanced research methodologies in communication studies.

As social phenomena seem to grow in complexity in the mediated world western societies live in, social scientists are invited to reinvent their methodological approaches, defying restrictive views on disciplinary boundaries. Aiming to discuss the most advanced approaches on research methods and techniques for studying communication issues, with a special focus on new epistemologies and qualitative approaches, this book aspires to be a space of inception of new ideas on how to imagine creative methodologies, as well as how to develop the inheritance of classic ones to the study of emergent and complex communication and media phenomena.

The book seeks to address questions concerning both the multiple dimensions of communication methodologies at the intersection of culture and communication, and the innovative methods for designing communication research objects of analysis.

In this volume, Nick Couldry (Goldsmiths, University of London) will specifically address the issue of the varieties of media practice, Eduarda Mendes Rodrigues (University of Porto) of social media network analysis, Álvaro Pires (University of Ottawa) will develop a Universal Theory of Observation for Communication Studies and Empirical Research, based on systemic theoretical approaches, Rosalina Costa (University of Évora) will tackle categorical analysis as a powerful tool to analyze old and new communication objects of analysis, as Dawn Mannay (Cardiff University) will explore ways in which Visual Methodologies may innovatively be used in media and communication studies.

Researchers are invited to send empirical research manuscripts covering one or more of the following themes:

- Visual Methodologies
- Media as Practice
- Social Media Network Analysis
- Qualitative materials: rediscovering categorical analysis

Authors are encouraged to write an article specifically for the volume. However, it is also possible to draw on in progress research, adapting this to address the volume theme.

# Topic

A wide range of contemporary research has shown how gendered attributions have been perpetuated in most areas of social life – work, school, art or family. If women are a majority in "feminine" fields, often associated with listening skills, gracefulness, empathy or managing emotion, men are a majority in "masculine" fields, mainly associated with strength, technical skill, rationality or assertiveness.

A wealth of studies has identified the social processes which limit women's access, orientation and promotion in "masculine" professional fields. But only a limited number of studies focus on men in "feminine" professional fields. Some of them suggest that men tend to progress more readily in their careers than their female colleagues when working in women's professions. It is also suggested that they find their day-to-day interactions at work easier enabling them to build up their authority with their managers, colleagues and customers. Some studies (sometimes the same ones) show the stigma men may suffer who work in "feminine" jobs. But those surveys do not assist our understanding of the general social processes which may explain not only why men do not easily get access to (or remain) in "feminine" fields, but also why the men who do, tend to fare better in their careers than their female colleagues. When and how do men choose (or do not choose) to access a "feminine" job? What are the social, personal and other factors which facilitate or prevent such transgressions? Which social processes best explain why men do, or do not, enter, remain and get promoted in "feminine" jobs? How do they justify such a choice, to themselves, and to others? Etc.

In this special issue, our ambition is, on the one hand, to gain a better understanding (and to explain) the social processes which lead young (and older) men either to reject, to escape or to unconsciously avoid "feminine" jobs, or in contrast, to transgress the gendered order. On the other hand, we also aim to better define the similarities and differences between men and women in terms of accessing and progressing in a particular profession. Here again, we hope to identify and better grasp general social processes which either help build up and legitimize men's presence in "feminine" professional fields, or lead men to reject or avoid those fields.

We expect proposed articles both to be built on empirical results and to develop an ambitious interpretive analysis of those empirical results.

#### How to submit a proposal

Up to a maximum of 500 words, each proposal will provide us with:

- an explicit title (even if temporary);
- a clear presentation of the issue to be discussed;
- a description of the field(s) and of the methodology;
- a quick description of main results which will be developed in the final article.

- Abiding by the submission requirements.

The committee will also ensure this special issue takes varied fields (both professional and geographical) into account.

# CALL FOR PROPOSALS TO ADD QUESTIONS TO THE 2014 GSS

# Summary. The General Social Survey invites proposals to add questions to its anticipated 2014 survey. Proposals will be accepted on the basis of scientific quality and scholarly interest. Outside funding is not necessary. The deadline for submissions is August 15, 2012.

Pending the availability of sufficient funds, the General Social Survey (GSS) project expects to include some items or topical modules designed by users in its 2014 survey, and invites users to submit proposals recommending such items or modules. Proposals submitted in response to this call need not be accompanied by funding that would support costs of data collection and data processing. They will be judged with their scientific merit as a primary consideration.

The GSS is a nationally representative survey of non-institutionalized adults in the United States, conducted primarily via face-to-face interviews. A National Science Foundation (NSF) award provides foundational support for the GSS, and if renewed would support inclusion of items submitted in response to this call; other sources provide supplementary support, typically to field topical modules. GSS data are collected every two years, and made available to the research community and the public as soon as possible after data collection is complete. Until 2004, the GSS was designed as a repeated cross-sectional survey. Beginning in 2006, the GSS design added a panel component. Through the use of appropriate sampling weights, each biennial GSS provides nationally representative estimates of distributions of survey items measuring a wide variety of social and political attitudes, opinions, and behaviors of U.S. adults. For additional information about the GSS and its study design, please consult the official NORC/GSS website at <a href="http://www.norc.org/GSS+Website/">http://www.norc.org/GSS+Website/</a>.

Beginning in 2010, the NSF award that funds the core GSS survey supported data collection costs for some user-contributed survey items. (This departs from GSS practice for the 1998-2006 period, during which proposed topical modules could be considered only if accompanied by funding from other sources. Such outside-funded proposals remain welcome, and investigators interested in initiating proposals for outside-funded items should contact Tom W. Smith, the Principal Investigator and Director of the GSS at NORC (<u>smitht@norc.uchicago.edu</u>; phone 773-256-6288).) This call describes the criteria for usercontributed proposals and the process through which decisions will be reached concerning them.

#### Proposals for New Content

Proposals submitted in response to this call may advocate inclusion of supplementary GSS content that varies in length, from as little as a single survey question to as much as a topical module of interrelated questions that might require 5 minutes or more of interview time. Proposals should articulate the specific research issues that the proposer would address and the scientific objectives that would be met if the proposed items were added to the GSS. Ideally, proposals will include the specific wording of survey items, document their past use and performance in other surveys, and present evidence bearing on the quality of data (validity, reliability, item nonresponse, etc.) they elicit. Demonstrating that items have proved fruitful in past published work, or that their inclusion would contribute to better understanding in key social science fields or interdisciplinary domains, can strengthen proposals. In some cases, however, users may be able only to suggest a general topic area and give examples of topics and types of items. Items that have synergies with existing GSS content, or that promise to interest a large number of GSS users, will be of interest.

Users are encouraged to think broadly and flexibly when considering what kinds of items to propose. They may, for example, propose to collect data from some subset of GSS respondents (e.g. employed persons, currently married persons, or persons who have attended religious services in the past year). Proposals for survey experiments that administer alternative question wordings to randomly designated subsets of respondents are also welcome; such experiments may address substantive social science questions, issues of survey methodology, or both. Statistical power considerations are relevant, since items can be measured for all GSS respondents or for some randomly drawn subsample of them. Proposals therefore should consider how large a sample is required to draw conclusions.

Proposals may suggest that items be added to the 2014 GSS as a one-time topical module administered to a nationally representative cross-section of US adults; most GSS topical modules have taken this form. Note, however, that it is expected that the 2014 GSS will collect baseline data for a three-wave panel study (with anticipated follow-up interviews in the 2016 and 2018 GSSs), so proposals for adding repeated content will also be entertained. Investigators who propose panel content should address the value of having data on within-individual change on items they propose. Because such proposals for repeated/panel content will be shorter (i.e., will involve fewer survey items) than those for one-time inclusion of items.

Proposers should be aware that NSF funding for the GSS project currently extends only through the 2012 survey. Successful proposals for items or modules submitted in response to this call will appear in the GSS only if sufficient funds to conduct its 2014 round are awarded. Any proposal involving repeated content would be accepted pending renewal funding of the project into 2016 and beyond.

The rotating panel design of the GSS initiated in 2006 means that each GSS round now collects data for a freshly-sampled cross-sectional sample, while simultaneously reinterviewing respondents from the two previous cross-sections. The reinterviews contain much of the interview time available to accommodate new content. For this logistical reason, much new content in 2014 would be administered to GSS respondents who were first interviewed in the previous two rounds (2010 and 2012), rather than to respondents newly sampled in 2014. Items in successful proposals received in response to this call therefore may appear as part of a 2014 reinterview with respondents to the 2010 or 2012 GSSs. Investigators may need to make use of weights that adjust for between-wave attrition in order to obtain appropriate estimates based on their items.

Generally, questions on the GSS are fixed choice survey items that are asked in a face-toface context. Other formats are also possible (e.g., self-administered items, open-ended items, card sort tasks, or stimulus materials provided via audio or video) but such variations often increase interview and development time, complexity and cost (coding costs are substantial for open-ended items, for example). Hence, items with such formats must serve an important scientific purpose in order to justify the additional effort required; proposals to add items using such formats should address this consideration.

#### Criteria for Choosing Content

The GSS attempts to provide high quality data in a timely manner to a large, interdisciplinary social science user community. Proposals to add content will be evaluated with this objective in mind by the GSS Board of Overseers and the GSS principal investigators.

The Board and PIs will use the following criteria in selecting and developing new content for the GSS:

1. Above all, new content must be of high scientific quality, appropriate to the GSS, and justified on substantive, theoretical or methodological grounds.

2. New content must be useful to a wide range of users (e.g., researchers, teachers, policymakers, etc.) that extends beyond the investigator(s) setting forth a proposal. New content ideally will enhance the understanding and/or usefulness of GSS items in the replicating core

(<u>http://publicdata.norc.org:41000/gss/Documents/Codebook/Replicating%20Core\_0707.pdf</u>), GSS data previously collected as part of a topical module, or data from other sources (e.g., to be used for comparisons).

3. A primary mission of the GSS is to study social change in the United States over time through replication of survey items. Items that contribute to this mission because they have previously been administered in nationally representative studies of US adults (including past GSSs) will be of interest for this reason.

4. Similarly, the GSS seeks to understand the US by comparison with other world societies. Proposals to compare and contrast the US with other societies by including items that have been administered in recent nationally representative studies conducted in other societies will be of interest for this reason.

5. New content must meet human subjects protections, in compliance with the GSS project's IRB approval, NSF and NORC policies. Investigators should determine whether they must also obtain IRB approval at their own institutions.

6. New content must fit within the overall time framework of the survey and must not interfere with respondent cooperation and/or the integrity of responses to questions later in the survey.

Time Line for Proposals and Development of Items

Significant lead time is required before new material can be included on a GSS survey. To be considered for inclusion in the 2014 GSS, investigators should submit proposals to Tom W. Smith, the Principal Investigator and Director of the GSS at NORC (<u>smith@norc.uchicago.edu</u>; phone 773-256-6288) no later than August 15, 2012.

Proposals submitted in response to this call will be reviewed by the GSS Board at its fall, 2012 meeting. At that meeting, some proposals will be selected for subsequent development, which will entail the exchange of advice and ideas between the Board, the GSS Pls, and the proposer(s), informed by both cognitive and conventional pretesting of items by NORC; such development may extend into 2013. The Board will review the status of the selected proposals at its spring, 2013 meeting; by then it will be essential that proposals specify the provisional question wording for all prospective items (if the wording was not available in the first instance).

The Board and PIs will select some sets of items for inclusion in a conventional pretest that will be conducted in the summer of 2013, which will establish (among many other

things) the actual interview time requirements of the proposed items. At its fall, 2013 meeting, the Board will make a final determination of the items to be included in the 2014 GSS.

It is important that investigators understand that inclusion of items in the GSS is not assured until they have undergone the full cycle of development described above, and until the GSS Board has decided to include them in the GSS at its fall, 2013 meeting.

Space on GSS

interview schedules is always limited. The Board and PIs may require changes in the wording of proposed survey items based on pretest evidence or other considerations, though such changes will be made in consultation with proposers. Likewise, due to the scarcity of interview time, the Board and PIs may elect to include only a subset of the items suggested in any given proposal.

After data are collected, they will be made publicly available to all GSS users along with the rest of the 2014 GSS, roughly six months after 2014 data collection is complete:

proposers will not have exclusive access to data collected using their items for any period of time.

At this point the GSS is unable to specify precisely how much 2014 interview time will be available to accommodate items proposed in response to this call. It can say that numerous proposals for items and modules of the kind described here were successful in adding content to the 2010 and 2012 GSSs.

[Investigators who have obtained, or might wish to seek, outside funding for their items should consult the document "Guidelines for Prospective GSS Module Proposals" available on the GSS website: see <a href="http://publicdata.norc.org:41000/gss/Documents/Codebook/gssguidelines.pdf">http://publicdata.norc.org:41000/gss/Documents/Codebook/gssguidelines.pdf</a>). Such proposals will be considered as part of a separate, but parallel, process.]

#### Proposal Length and Format

Proposals submitted in response to this call should be roughly 2-5 pages in length, and should address the following points:

1. The background and the scientific, theoretical, or methodological motivation for inclusion of the topic in the GSS. Proposals for repeated/panel content should address the gains to be realized by obtaining data on within-individual change on the subject; 2. The specific topics, and ideally the specific survey items or questions, that would be included in the GSS, together with any evidence of the quality of the data they elicit; 3. Previous knowledge about the appearance of the items, or items on similar topics, in the GSS or other surveys, and their use in published research; 4. The appropriateness of the GSS for the proposed items, to include any synergies they may involve with GSS project objectives or existing GSS items; and 5. Proposals for questions about multiple topics should indicate the priority assigned

to measuring the different topics in the GSS. Likewise, proposals to measure a given topic using multiple items should indicate which items have higher and lower priority for inclusion.

Proposals from groups of investigators as well as individual investigators are welcome.

When similar calls for proposals were issued in 2010 and 2012, the GSS received many more proposals for new content than it could accommodate. The Board and PIs will review and discuss proposals submitted in response to this call, and then notify investigators as to whether or not their proposals were selected for further development. At that point, the Board and PIs may request that investigators provide additional information, and may suggest that separate groups of proposers with interest in similar topics collaborate as part of working groups to develop a topical module. The Board will provide investigators who submit unsuccessful proposals with brief summaries of reasons that their proposals were not selected, but cannot offer detailed critiques.

economic behaviour and markets at the micro, macro and international levels, and to organizational design and human resource management.

Besides providing solid foundations in the relevant disciplines, the Programme is marked by its focus on methodologies for rigorous empirical and behavioural approaches to economic and managerial studies, ranging from more traditional techniques to the more recent developments in the experimental and computational fields.

# PhD in Local Development and Global Dynamics (3 scholarships)

The programme aims at providing knowledge about the processes of development of local systems in a global context, research skills and political and administrative functionaries of the local government. The programme has an interdisciplinary character and a comparative approach. It includes aspects of Economics, Sociology of Institutions and of the regional planning; it is based on a long-lasting cooperation with European and non-European Universities and with international institutions like OECD, UNDP, etc.

# PhD in Sociology and Social Research (8 scholarships)

The doctoral programme in Sociology aims at forming highly qualified researchers able to do both applied and fundamental research in universities and scientific research centres or market research institutes. The systematic integration of theory and empirical research is one of the core principles of this doctoral programme. To that end, students are provided with courses on classical and contemporary theoretical readings, guided through the in-depth study of sociological theory and stimulated in their own theoretical reasoning. As social theory has to highlight and to guide front-edge empirical research, students are furthermore instructed in contemporary social science research methods and advanced quantitative and qualitative techniques, necessary for the realisation of successful research projects. Particular attention is placed on interdisciplinary competences especially in the research areas of the Department of Sociology and Social Research.

All programmes are conducted in English and will be taught by members of the university's multinational faculty. No tuition fees are charged and the scholarships are adequate to cover living expenses in Trento. Scholarships will be augmented by 50% for authorised research periods spent abroad.

#### Missions of the postdoctoral researchers

These postdoctoral research contracts are intended to complete the training of young researchers and act as a springboard for their academic careers. The postdoctoral researchers' main activity will be to build on their thesis and implement the research project for which they have been selected, in collaboration with and supported by their host laboratory.

The postdoctoral researchers will take part in the collective scientific activities of iPOPs and their host unit (at INED or one of its partner institutes in iPOPs). They will attend seminars where they can present and collectively discuss their research progress. They will also be able to help organise research activities of common interest (e.g. preparing workshops, study days, lectures or other events). The time devoted to these activities should not exceed one-fifth of their working time.

Each postdoctoral researcher will have a mentor among the researchers in their host unit. The mentor's role is to advise the postdoctoral researcher in the course of their work, if need be. Mentor and postdoctoral researcher may collaborate on one or more research projects.

#### **Conditions of contract**

Postdoctoral researchers are hired under a fixed-term contract of one year, renewable once. Renewal is conditional on submission of a short report of their work (maximum 5 pages), specifying what they have accomplished during the first year and the work remaining to be done in the second year.

The gross monthly salary is €2336 (€1901 net). Thesalaries of postdoctoral researchers with at least three years' experience in research since their PhD may be raised, to a gross salary of up to €2584 (€2103 net).

At their request and depending on the host structure, the researchers may receive special financial support for missions connected with their research or their participation in science events.

#### **Conditions of admission**

 $\rightarrow$  Applicants must hold a PhD degree delivered since 01/10/2007 in a discipline connected with population science (demography, economics, epidemiology, history, sociology etc.), or be registered for a thesis which they are scheduled to submit before end 2012. NB: selected applicants who have not submitted their thesis by 31/12/2012 will lose the benefit of the postdoctoral fellowship.

 $\rightarrow$  The applicant must do their postdoctoral research in a laboratory (or team) other than the one in which they did their thesis work.

 $\rightarrow$  There are no age or nationality criteria. However, applicants over the age of 35 must provide evidence of their atypical career (professional experience other than postdoctoral research).

#### Selection criteria

The selection committee takes the following criteria into account:  $\rightarrow$  the quality and originality of the research project, which must fall within the themes of the iPOPs laboratory;

 $\rightarrow$  the applicant's profile and aptitudes (scientific skills, research experience, publications);

 $\rightarrow$  research experience outside the home country (periods of study abroad, publications, language skills);

 $\rightarrow$  the relevance of the affiliation applied for.
