One International Relations or Many?

Multiple Worlds, Multiple Crises

8th Pan-European Conference on International Relations

Wednesday 18 - Saturday 21 September 2013, Warsaw, Poland

Organised by

the Standing Group on International Relations in cooperation with the Institute of International Relations, University of Warsaw and the Polish Association for International Studies

'The world in crisis' is a phrase that we often hear, especially in recent years – be it the eurozone crisis, the global economic crisis after the collapse of Lehman Brothers, the crisis of legitimacy for a number of states in North Africa and the Middle East, the crisis of US hegemony, climate change and (un)sustainable development, and so on. Curiously, this has led to remarkably little self-reflection among International Relations communities, especially with regard to two key aspects of the phrase: (1) whose 'world' is it that is in crisis, and (2) what is labelled as a 'crisis' and what is not.

This forces us to ask why and how this might be the case; in particular, this Call for Papers calls attention to the ways in which contemporary 'real-world' crises are frequently viewed as indicative of crises of the paradigms and frameworks promoted by others and not ourselves. As such, this conference asks whether IR is able to respond effectively to the challenges posed to its assumptions and frameworks as such. That is, if international relations is characterised by multiple worlds and multiple crises then what does this say about the discipline of International Relations?

We are particularly interested in the plurality of perspectives that exist within (and can be brought into) IR in order to highlight how these different perspectives allow us to see four things: (1) our view of IR as a discipline; (2) our conception of 'the world(s)' that we live in and study; (3) our view of what is important and/or appropriate for IR to study in the world(s) that we live in; (4) our assessment of crises and their significance, which extends to whether we view them as crises or not in the first place (and thus the question 'crises for whom?'). In other words, are there many rather than one International Relations and does this mean that there are multiple worlds and crises which IR scholars could study? And why and how does this matter?

While participants are especially invited to respond to the conference theme, proposals on all aspects of International Relations will be considered (please see below). A Call for Panel and Paper proposals will be issued later this year.

Call for Section Chairs

The academic programme for the conference will be organised in the usual SGIR format of sections composed of panels. The conference can host up to 30 parallel sections. A section may consist of

either five or ten 105-minute panel sessions during the programme. Each 105-minute panel should comprise four to five papers plus discussant and chair.

The tasks for a section chair include:

- · proposing a section around a theme; populating some panels at the proposal stage; maintaining a balance between established and new-coming scholars, and postgraduate students;
- · composing the rest of the section's program, by selecting papers that were proposed in response to the call for papers;
- · identifying panel chairs and discussants;
- · taking overall responsibility for the actual execution of their section's contribution to the conference programme. This final task includes the selection of best paper by a research student in their section.

Proposals for sections should include:

- 1). Name, institutional affiliation and email address of the proposed section chair(s).
- 2). Proposed section title and summary of its theme(s) and rationale(s) (no more than 250 words). Please state here if your proposed section is to contain 5 or 10 panels.
- 3). Tentative indication of possible panels (panels do not need to be complete, and nor do we require a full list of panels, but a minimum of two papers per panel is desirable). This could, if you so wish, include roundtables (in which case please indicate at least two members of the roundtable line-up).

Inequality and Integration in Times of Crisis

Since Karl Marx first described the enormous social inequalities and their potential for social change at the beginning of industrialization in the 19th century, the origins, extent, and consequences of social inequality, as well the level of inequality which a society is willing to tolerate, have been major themes in sociology. Our discipline has taken on the theme of inequality in multiple areas ranging from research on unequal educational and labor market opportunities, unequal income distributions, gender and health inequality, and inequality in life expectancy, to mention only a few. There are innumerable national and international conferences devoted to these themes.

Do we need yet another one? Is inequality still a problem in our society?

The answer to this question is undoubtedly yes. In particular, the economic crisis at the start of the 21st century underlines the fact that the theme of inequality has not lost its relevance. Above all, the European debt crisis inclines us to suspect that social inequality is growing. In comparison with economic boom times, almost all the European countries feel the pressure of stabilizing their economies and cutting back on public expenditures. This will also impact redistributional policies to reduce inequality and bring about new challenges for integration policies addressing the emerging disparities. At the same time as inequalities within European societies are exacerbated, disparities between states are also rising, which will likely have adverse effects on European unification, not to mention creating new challenges for Switzerland as well.

The European debt crisis came at a point in time when global environmental and demographic problems worsened simultaneously – the aging of industrialized countries and population explosion in developing countries. The inequality effects of climate change and the unequal distribution of

population growth will lead to an increase in migration and elevate the immigration pressure on the European Union and Switzerland. For this reason, Switzerland, as well as the other European countries, grapple with questions of managing migration and integration.

Inequalities – as problematic they may be – are also in some sense an opportunity. They increase the diversity of society and can bring about new ideas, innovation, and growth. Our desire and ability for social integration depends, above all, on the ultimate balance between these advantages and disadvantages. Within the framework of the various foci of the research committees, the conference will concentrate on the opportunities as well as the risks associated with these social changes.

If you would like to organize a plenary session, please submit the title of the plenary as well as the designated contributions (including titles, abstracts, and the names of the contributors) to the organizing committee by January 15, 2013 (by e-mail to sgskongress2013@soz.unibe.ch). A plenary session usually includes three contributions.

If you would like to organize a workshop (parallel session), please submit the theme proposal and call for papers for the workshop to the organizing committee by November 30, 2012 (by e-mail to sqs-kongress2013@soz.unibe.ch). - Authors of accepted papers who registered in the conference can have access to the evaluations and possible feedback provided by the reviewers who recommended the acceptance of their papers/abstracts, so they can accordingly improve the final version of their papers. Non-registered authors will not have access to the reviews of their respective submissions.

The organizers would like to emphasis the problems related to the sources and results of contemporary wars and conflicts.

The focus will be made on many factors just to mention some of them: social and ethnic consequences of the conflicts, especially genocide; neocolonialism and modern art of slavery; conflicts between cultures; wars for natural resources, "demographics bombs"; new social order as well as visions of the future development of Europe. During the conference the results of scientific findings both empirical and theoretical will be presented in view of sources, scale and effects of modern armed conflicts.

The main idea of the conference is analyzing of phenomena and paradox of the present days regarding to discord between international and national interests, which seems to be main reason of the current conflicts. The problem is discuss in literature, media and in speeches of politicians who spread watchwords about peace, tolerance and global negations of an evil. It generates the subtitle of the conference "paradox of a war in the modern world order" which is support by scientific data coming from about 200 wars and conflicts in different scales from 1945-1950 conducted by 60 UN countries. Building blocks for an inclusive society: empirical evidence from social policy research

LUXEMBOURG, April 18 & 19, 2013

Conference Description

The joint IMPALLA-ESPANET* conference on 'Building blocks for an inclusive society: empirical evidence from social policy research' will take place on April 18-20, 2013 in Luxembourg.

Organizers

CEPS/INSTEAD (http://www.ceps.lu), the Social Science Research Centre in Luxembourg is organising this Conference in the framework of the International Master of Science in Social Policy Analysis (IMPALLA) (http://kuleuven.be/impalla): an advanced Master programme in Social Policy that is run by CEPS/INSTEAD – Luxembourg, the University of Leuven – Belgium and associated institutes (Tilburg University – the Netherlands, University of Nancy 2 – France and the University of Luxembourg). IMPALLA is running since 2002 and the majority of its graduates is employed by universities and institutions that are involved in research in many fields of social sciences.

The **Network for European Social Policy Analysis** (ESPANET) (http://www.espanet.org) is an association of academics involved or interested in the analysis of social policy in European societies, the social policy of the European Union and of other cross-national bodies. ESPANET has a long experience in organizing conferences, seminars and workshops in social policy in Europe.

Content

The legitimacy of welfare states is based on the willingness to provide the tools for achieving an inclusive society. This implies that life chances are partly detached, or decommodified from social and economic origins and circumstances. The core of an inclusive society is to create equal opportunities and equal access to services and infrastructure for specific groups such as unemployed and disadvantaged people, disabled people, children and adolescents, older people and pensioners, ethnic communities, etc.

The joint IMPALLA-ESPANET conference seeks to tackle the following questions:

- What are the essential building stones for welfare states to accomplish an inclusive society?
- How to avoid marginalization: activation versus means-tested?
- Which policies respond to the flexibility required on the labor market?
- How can welfare states reach participation into society in social, political and economic spheres while respecting diversity?
- How to empower the disadvantaged?
- How could education and family capital underpin an inclusive society?
- Given today's demographic, economic and political pressures as well as financial constraints, welfare state reforms are on the political agenda, not only in Europe. From which European and global best practices can social policy-makers learn? How to coordinate action at local, Member State and the EU level?

Our objective is to encourage an interdisciplinary dialogue between academic researchers and policy analysts. The organizers welcome abstracts for empirical papers and panels around the themes mentioned.

The conference committee encourages IMPALLA Alumni who have finished their PhD or are doing a PhD to submit a paper. There will be an alumni gathering with some Alumni social activities.

Potential paper topics may include but are not limited to:

- Exclusion in education and the labor market
- Income distribution, poverty and financial inequality
- Living conditions
- Health and wellbeing
- · Family formation and child care
- The family as social, cultural, and economic capital, and educational attainment
- Social protection and old-age pensions
- Social integration and networks
- Political and cultural participation
- Attitudes towards the welfare state and social cohesion
- Gender equality/ empowerment of women
- Combating social exclusion: intervention programs, implementation and evaluation

In this framework, the conference will be organized in the following sessions:

- Intergenerational redistribution
- Education and human capital
- Social exclusion and solidarity
- Labour market
- EU policies and politics

Relevance for Luxembourg

The conference aims at stimulating further research on social policy issues in Luxembourg. This is particularly important in the context of the current political debate in our country that involves reforms of several intergenerational income redistribution schemes such as the pension scheme and family allowances.

For a number of years, a reform of the educational system of Luxembourg is also in preparation. The implications of the education reform are far reaching, because school is at the core of the integration of immigrants, creating human and social capital that contribute to preventing labor market and social exclusion. In addition, family social, cultural and economical capitals are very important for student success in a diverse society, which implies that a share in research and practice on how such capitals could be efficiently used is very beneficial for Luxembourg and Luxembourgish researchers and practitioners.

The increasing incidence of unemployment in the past few years has prompted political decision-makers to create a number of measures to help job-seekers find employment, and research on how efficient such public measures are called for.

The conference aims also at deriving useful results concerning the social policy of the G.D. of Luxembourg. The comparison of several European and non-European welfare states will provide important insights into the policy measures that are relevant in the Luxembourgish context.

Presentations of recent results concerning research and practice in other countries will undoubtedly lead to an exchange of best practices, of data and methods, in the area of social policy.

Moreover, the Conference will strengthen the research network and attract senior and young researchers to Luxembourg. This will increase the visibility of Luxembourg as a research country,

considering the large international networks of the organizers, namely the IMPALLA program and ESPANET.
