## 3rd Energy & Society Conference Midterm conference of ESA RN 12 "Transforming Energy for Society"

Leipzig, Germany, September, 12-14, 2016

## About the 2016-conference theme

While global oil and gas supplies are subject to geopolitics, the concrete form of a particular energy regime is often an issue of national politics. Energy policies are foremost legitimised in a national context, but they also relate to the international discourse on climate change mitigation as well as practices on the local level. The consequences of increasingly diverging pathways thus have implications for single nations as well as for global politics.

These issues present important questions for social research, regarding discourses of risk, acceptance and legitimacy, investment and costs, (changing) practices of energy consumption and production, and evolutions in actor networks.

We encourage submission of abstracts for presentations and posters in a wide variety of topics (see full description of the program and the sessions here). Workshop proposals are also welcome.

## Sessions and Submissions

- Abstracts (oral and poster presentations): 150-200 words. Please indicate your preference regarding the format (presentation in a session, poster, round table) and session topic
- Workshops (90 min.) proposals are invited in different formats with a focus on thematic, methodological, and/or theoretical discussions. They can include up to four presentations. If the workshop is planned to include individual presentations, the workshop organizer also needs to include a title and abstract of each presenter's paper (150 words and affiliations).

# Key Information

Authors cannot present more than one paper but can be co-authors of other papers. Abstracts must be submitted in English.

The deadline for the submission of abstracts and workshop proposals is **January 10th 2016**. Authors will be informed whether or not their abstract or workshop proposal is accepted by 1st of March 2016.

The fees for the conference are to be for early bird registration 50 Euro for ESA members, 60 for nonmembers, 30 for students. Registration will open from March to July 2016.

# Special Issue of European Journal of Cultural & Political Sociology in 2016

Neoinstitutionalism and world society theory: global-local entanglements

**Guest editor:** Dr. Ali Qadir, University of Tampere (Finland) and European Sociological Association Research Network on Global, Transnational & Cosmopolitan Sociology

Challenging rational-choice and functionalist theories of society and organizational life, sociological neoinstitutionalist approaches have had great success in explaining similarities across world society. World society theory, in particular, stresses the role of culture, maintaining that institutions shape and limit the understanding of options open to actors. Empirical and theoretical accounts have focused on the role of intergovernmental and international non- governmental organizations in shaping world culture. Recent scholarship has developed these approaches to also account for apparent local variations, domestication of global trends, and travels of ideas.

The aim of this special issue is to contribute to extending world society theory by attending more closely to the local-global interface. This call invites papers from scholars who approach social phenomena from a neoinstitutionalist perspective. Topics exploring local-global entanglements may include, for example, the dynamics of formation, diffusion and domestication of transnational models; regional institutions and practices; new conceptions of the 'global'; travel of ideas; and adaptation of worldwide cultural fashions. Theoretical papers as well as empirical studies that develop world society theory are welcome, as are both quantitative and qualitative analyses.

All articles will be subject to the journal's usual practices of double-blind peer review and must conform to the iournal requirements of style and format (see journal website at http://explore.tandfonline.com/cfp/bes/recp-neoinstitutionalism). Manuscripts should be between 6000 and 10000 words, including references and notes. Submitted papers should not have been previously published nor be currently under consideration for publication elsewhere. Submissions must be made via the journal's online submission system with the cover letter indicating that the manuscript is for this special issue.

From June 8 to 11, 2016 will take place in Bergamo (Italy) the 6th Conference of Ethnography and Qualitative Research, organized by the University of Bergamo in collaboration with the journal *Etnografia e Ricerca Qualitativa* and the Italian publisher *II Mulino*.

The present call for papers solicits either ethnographic or qualitative contributions that deal with *the theme of invisible resistances in the realms of everyday life, labor and public space*, and that show how politics and struggles move to private and quotidian plans, often illegal, which parallel the more conventional forms of collective action. The Programme Committee of the Congress announces a call for thematic panels on conditions detailed out below.

Basic conditions of the Congress participation:

- **One cannot** give **two papers** or other "presentations" (poster, distributed paper etc.) during the Congress.
- Panel presenters cannot all come from one research team/institute/ university/department etc.

## Thematic panels:

A thematic panel proposal can be submitted by:

- a) minimum two persons,
- b) these persons need to be from two different institutions,
- c) at least one of them needs to have a PhD.

### The deadline for submitting thematic panels proposals is October 31, 2015.

The proposal should contain:

- a) Names and last names of the persons submitting a panel proposal,

# 24th Sociology of Health and Illness Monograph

## Materialities of Care: Encountering Health and Illness Through Artefacts and Architecture

Editors: Christina Buse, Daryl Martin, Sarah Nettleton (University of York)

Proposals are invited for the 24th Sociology of Health and Illness monograph, which explores the role of material culture within health and social care encounters, including everyday objects, dress, interiors and architecture. Everyday artefacts actively mediate practices, identities and lived experiences of health and illness, prompting reflection on medical and care practices; professional status: social divisions and distinctions; and embodiment. Science and technology studies literature has drawn attention to materialities in medical practice medical technologies. experimental (e.q., materials and instrumentation), but more mundane aspects of material culture have received less conceptual attention. We invite papers which use an analysis of everyday 'things' to engage with wider issues within medical sociology, as well as speaking to interdisciplinary literatures. Papers which consider the experience of care providers or those receiving care are welcomed, as are papers examining the perspective of designers and architects, who are not normally considered healthcare professionals, yet shape landscapes of care. In particular, submissions which add conceptual and empirical depth to discussions of materialities in health and social care are encouraged, as well as those which are reflexive about methods for capturing materialities.

Possible themes include:

- the relations between bodies, materialities and care
- how things mediate embodied, tacit and sensory ways of knowing;
- the ordering and management of materialities in health and social care settings;
- the interaction of objects and artefacts with lived experiences and narratives of health and illness;
- the relation of architectural and interior design to imaginings of health and well-being;
- the interplay of material culture with identities, social divisions and distinctions.

The monograph will appear both as a regular issue of the journal and in book form, with the journal issue to be published in February 2018. Potential contributors should send an abstract of up to 600 words to <u>Christina.Buse@york.ac.uk</u>, <u>Daryl.Martin@york.ac.uk</u> and <u>Sarah.Nettleton@york.ac.uk</u> by **30th January 2016.** Name and institutional affiliation of the author(s) should also be supplied, including full contact details. We encourage international contributions, which will allow for cross-cultural comparison across the collection, as well as contributions from authors at a range of career stages, from early career to more established writers. Informal email enquiries prior to submission can be sent to any of the editors. Abstracts will be reviewed and potential authors notified by 1st March 2016.

Short-listed authors will be invited to submit a draft paper of 7,000 words by 1st July 2016.

# The legitimacy and effectiveness of gender quotas in CE Europe

The study of gender quotas is a growing area of political and gender studies. However, the issue of gender quotas remains relatively understudied in the Central East European region, despite the fact that almost all countries in the region have adopted some kind of gender quotas (legislated or voluntary party). Differences in political legacy,

leading ideologies, party systems as well as differences in attitudes towards gender equality policies and the strength of women's movement are among those factors which might had led to variation in the pace of changes in women's political representation and in the adopted policies to change women's historical under-representation. We invite country case studies as well as comparative studies of the legitimacy and effectiveness of gender quotas in the region. We welcome studies that critically discuss existing research in the field.

Sociological Imagination, the Journal of the Wisconsin Sociological Association, invites submissions for a special issue on "Germany: 25 Years After Reunification," edited by F. Peter Wagner, University of Wisconsin - Whitewater.

# The Theme:

The Federal Republic of Germany and the German Democratic Republic signed the Unification Treaty on August 31, 1990. On March 15, 1991, the Two Plus Four Treaty went into effect, giving the reunited Germany full sovereignty. The special issue aims to analyze and critically assess the changes in and for Germany as well as the impacts that the reunited and sovereign Germany has had and continues to have in European and international affairs. Thus, submissions are invited from a variety of disciplines and methodological bases on a variety of topics including, but not limited to, continuing socio-economic and cultural West/East divides in Germany, Germany's political development and Germany's political economy since the 1990s, Germany and migration (also Germany's role in the current refugee crisis), Germany's foreign and security policy, and Germany's role in transatlantic relations.

## Submission guidelines:

Submissions for the special issue are due **March 14**. They should follow the American Sociological Association's style guidelines and not exceed 25 pages in total length. All authors will be informed about the status of their respective submissions in a timely manner. The publication date of the special issue is set for mid-June 2016.
