40 years of democracy (s): progress, contradictions and prospects is the overall theme of the VIII Portuguese Sociological Congress, to be held at the University of Évora, from 14 to 16 April 2014.

Calling out to the participation of foreign and domestic specialists, the VIII Congress, following previous editions, intends to continue to deepen Portuguese sociological exchange beyond boarders, searching for continuities in accumulated knowledge, but also creating opportunities to the expression and confrontation of new approaches.

Similar to previous editions of the Portuguese Sociological Congress, proposals for communication/posters will be accepted for sessions dedicated to each thematic session [TS] or thematic area [TA] (in the case of the domains where there still aren't thematic sessions already created by the APS).

Proposals with empirical work on different national contexts will also be accepted if they reveal conceptual and analytical tools which can generate dialogue with other proposals.

International Conference "Food, Children and Youth: What's Eating?" Lisbon, Portugal February 21 – 22, 2014

Children and youth food practices are becoming increasingly perceived as problematic, reflecting concerns on childhood overweight and obesity rates in several countries. Apart from issues with excess food, food deficit problems (malnutrition, food security) are becoming ever more present in both developed and developing countries, since the rise in fuel, energy and food prices (in the aftermath of the 2007-2008 crises and the austerity measures forcefully applied in some countries). Both food surplus and deficit are having major repercussions on the health and wellbeing of children and youth. It is noticeable a moralization of children and youth food practices in many sites as diverse as food shopping outlets, media discourses, TV adverts, food packaging, schools, education and health policies, and even family households. Various policies and initiatives have been designed to tackle perceived risky and unhealthy diets by children and youth, and some innovative initiatives on school meals and food education have offered interesting insights on how to push the public and private sectors' agenda towards healthy, sustainable, secure and socially just food. In all these debates, policies, and strategies, visions of "eating well" are put forward, often clashing with everyday life children's and youth foodways in schools, in commercial spaces, among friends or family. This conference addresses a general theme: what's eating? In other words, how are children and youth eating practices configured and re-configured, contested and normalized, through symbolic, cultural, material, embodied, social and political contexts, across time and space? We welcome abstracts both from established scholars and post-graduate students coming from diverse disciplinary backgrounds and engaging with different theoretical and methodological approaches. The best papers of the conference will be considered for publication in a special issue to be proposed to a high quality international peer review journal.

The working language of the conference will be English.

Abstracts will be reviewed according to the following criteria: 1) whether the paper will make an original, understandable, and meaningful contribution to children, youth and food debates; 2) What research or evidence the paper is based on; 3) Which existing theories and concepts the paper is engaging with

- -Food and migration: continuities and disruptions
- -Eating in times of austerity: changes in institutional configurations and practices
- -Development and acquisition of new food tastes and competences
- -Media representations of childhood obesity and malnutrition

Call for Papers:

The problem of diffusion situates us at the junction of theoretical perspectives and methodological approaches of various research fields in social sciences. The common tendency of recent sociological treatments of diffusion is the zooming in on the processes taking place when ideas and objects circulate – such as mobilization, adaptation, theorization, dis-embeddedness and re-embeddedness, construction, hybridization and editing. Such focus is considered to link diffusion with heterogeneity and to challenge the institutional isomorphism perspective which depicted it as leading to homogeneity in organizational fields. It is also an approach to diffusion which advances a deeper, more ethnographic and descriptive analysis of the phenomenon.

The Workshop depicts this theoretical turn as the evolution of research interest from the diffusion of practices to practices of diffusion. The formula is suggestive as it also catches the nowadays research interest in diffusion as a social phenomenon in itself, and not just as one of the stages within a sequential process. The Workshop wishes to discuss and reconsider these theoretical developments on the basis of diffusion studies pertaining to the circulation of ideas, rules, procedures, regulations, classification systems and standards in culture, law and economy. The research of practices diffusion across organizations and legal systems evolved from the study of diffusion paths and means to the content and form of the ideas circulating. In addition to these developments, the Workshop also aims to consider diffusion processes at various levels of formalization, unsuccessful circulation processes, as well as efforts aimed at curbing the spread of certain practices and regulations.

The Workshop welcomes papers dealing with such topics as:

- Theories and models of diffusion in social sciences;
- Mediation, abstraction, transformation and editing of ideas, procedures and regulations during their implementation phase;

- o Diffusion of practices and the construction of cultural categories of adopters;
- Social and cultural embeddedness of diffusion processes;
- The relationship between diffusion and institutionalization;
- The relationship between diffusion and institutional isomorphism;
- o Unsuccessful diffusion phenomena in legal, organizational and economic fields
- Anti-diffusion activities and processes in legal, organizational and economic fields.

Arts in practice. Transgressing, subverting or clouding gender *Ethnologie française* Journal Special issue (2016-1)

Argument

Quantitative and qualitative surveys repeatedly reveal that artistic practices are gendered, whether they are professional or amateur, whether they happen in early childhood, adolescence, youth, adult life or in retirement. Women become singers, dancers or actors, while men become instrumentalist, photographers or videographers. And even when men and women engage in the same artistic practice, they perform or are perceived in a gendered way.

Several individual and collective publications have addressed this issue in the past ten years¹, mainly focused on the reproduction of gendered differences in arts. But we still lack a systematic comparative discussion of how gender can be transgressed, subverted or diverted through artistic practice: men who dance, play the harp or sing; women who work as jazz instrumentalists, perform as clowns or dance hip hop; "androgyneous", "queer" or "trans" art performances; humorists putting on drag; women acting as men, men acting as women; "feminine" artists aiming at "universal" recognition; art performances inverting gendered stereotypes...

Explanations of these gendered transgressions, subversions or transformations are numerous and complex. Understanding them requires a precise observation of men's and women's practices and representations. One needs to empirically study – either ethnographically or historically - creative acts and learnings, body language, know-how and social skills...

This special issue intends to study the processes underlying gendered transgressions, subversions, clouding or transformations of artistic practices, in both past and contemporary societies, to illuminate this question in a renewed and original way while taking existing works into account.

We want articles which will compare how gendered frontiers are drawn, produced and blurred over time, underlining key processes shaping gendered transgressions or subversions of artistic practices.

We invite original proposals which address this issue empirically in any of the arts: theatre, circus, literature, music, plastic arts, cinema...We welcome proposals which study contemporary, as well as historical, cases from all over the world, perhaps focussing on specific life-spans in order to better grasp social contexts and distinguish primary and secondary socializations.

We have drawn three main axes which can be questioned separately or combined. This does not exclude other ways of approaching the issue, as long as transgressing artistic practices remain the primary focus. All proposals must be based on specific empirical research.

How policies and formal devices influence transgressions

Can we identify public policies, geographical spaces or cultural institutions which help transgressions happen? Are transgressions influenced by media, social or political device?

How family, scholarly, professional or leisure socialisation influences transgressions

What family, scholarly, professional or leisure socialisations influence these transgressions? Are they shaped by social logics which differ depending on age? Are they due to specific social or "ethnic" origins or formal training? How are transgressions or subversions embodied - gestures, words, looks...?

How artistic practices, transgress and receptions occur

How are transgressive artistic practices performed? How are they perceived and by whom? How are they visibly and objectively subverted? How does the performer's social environment (family, friends, colleagues, critiques, producers, etc.) react to such transgressive or subversive practices? How do actors overcome stigmatisations and/or labelings in their daily life?

The Invisible Boy

International Multidisciplinary Research Project

In June 2012 The Invisible Girl project (see <u>https://iml.edusci.umu.se/invisiblegirl</u>) was completed with the publication of the book Invisible Girl and a conference in Umeå, Sweden. It is now time to launch a new project, aiming at the publication of another book.

The Invisible Girl project was underpinned by the assumption that we live in a sexist society, where girls and women are underprivileged, stereotyped and discriminated. However, this does not mean that men in general suppress women or that men and boys in general are privileged. The sexist power structure seems to have negative consequences for both sexes. Men generally have a shorter life expectancy than women; boys can be noted to under-achieve in certain school subjects, boys who are sexually abused and boys with eating disorders are made invisible. So it was only natural for us to decide that our next project will be the Invisible Boy.

This is a call for participation in our multidisciplinary research project *The Invisible Boy*. What does it mean to become a boy today? How does boyhood manifest itself in different contexts? How can we describe fathers and sons in contemporary society? Can we make the invisible boy visible in ways alternative to those of media?

We invite researchers and artists to contribute with research papers, works of art or anything else providing critical perspectives to studies of boys and boyhood. Please send us your proposal, which should be no longer than the equivalent of one page of text, before October 1, 2013. The selection process will take place in October and November and all contributors will be notified before December

1. The authors selected for publication will be asked to send in their final contributions by March

1, 2014. Publication is estimated to take place in the winter of 2014.

Please don't hesitate to contact us if you have questions. We hope that you are interested in contributing to the Invisible Boy or that you know someone who might be. Please feel free to distribute this call widely. If you want to follow the development of the project there will be updates on the website, see below.

'All Things to All People?'

Internal and External Approaches to Europeanisation

The recently established Global Europe Centre at the University of Kent is organizing a workshop on the operationalisation of **Europeanisation**. Europeanisation is a popular concept in the field of European Studies, however, academics fail to agree on a singular approach to operationalisation and what methods could be applied, whilst its application has been extended from the Single Market to include all areas of public policy, including External Action.

Therefore, the Global Europe Centre would like to invite you to attend an interdisciplinary workshop on aspects of internal and external Europeanisation, organized for PhD students who apply the concepts in their own research. The event will include a key note lecture by **Professor Ian Manners** on **31**st **October 2013**. The lecture will be followed by a one-day workshop on 1st **November 2013**. Both the key note speech and the workshop itself will take place at the University of Kent, Canterbury.

Participants will be encouraged to present on how they operationalise the concept of Europeanisation in their own research. The panels will be divided based on internal and external Europeanisation, which will be followed by a round table on how the two dimensions can be compared. The workshop will have an interdisciplinary character, and aims to address Europeanisation not only from political, but also economic, legal or other perspectives.
