Dr Phil Henry (University of Derby) a sociologist of religion working in the area of identity and difference and Director of the Multi-Faith Centre at the university; 3. Jon Jolly (Arun Community Church) a Christian youth worker, writer and key thinker in the field. The speakers have been asked to stimulate reflection and discussion of practice relating to young people and faith by drawing on the insights of their work and research interests. Adjusting to Europe: Institutional Legacies of Communism and Ethnocultural Diversity

Date: August 29-30, 2011 **Site:** Kaunas, Lithuania

Organiser: European Centre for Minority Issues

Topics: The impact of the European norms, standards and policies of minority rights protection on the countries of Central Eastern Europe and in the states of the former Soviet Union have been intensely studied. However, the institutional dynamics inherited from the Soviet nationalities policies have barely been in a focus of interest. The conference asks how institutional legacies of the past impact on policies supporting minority communities in the new Europe since a range of the formerly communist states have accessed the European Union. Much academic and policy-oriented research has been done on the impact of European norms and institutions on the post-communist democratisation, yet none on the reverse influence. Now, 20 years following the demise of the Soviet states and its nationalities policies, we ask how the European political institutions reflect the experiences of the communist era and whether, and if so how, the institutional dynamics are reflected in the EU relations with its postcommunist neighbours. The issues to be addressed include - but are not limited to - interpretations of social equality, ethnocultural development, ethnic representation and autonomy, all addressing the "systemic hypocrisy" in coping with ethnicity-based claims. The organizers are explicitly interested in contributions assessing the convergence and/or conflict between the communist ethnic policies and the minority protection standards in contemporary Europe. The conference seeks to raise questions about the role of communist institutional and

ideological legacies in contemporary European minority politics. Preference will be given to theory-driven papers that assess norms and policies of minority accommodation, non-discrimination and cultural diversity diachronically. A comparison of communist states' - understood here as republics of the USSR and SFR of Yugoslavia, as well as the European states, members to the Council for Mutual Economic Assistance - "nationalities policies" with the instruments of minority protection in contemporary Europe is highly encouraged.

Topics: The organizers are strongly interested in papers that explore the limits to developing a global consciousness or varieties of cosmopolitanism as outcomes of global cultural experiences and/or which critique concepts in this field. Although the primary emphasis here is on cultural experiences, the organizers also welcome papers which explore how exposure to globalizing work, religious or political practices are changing people's identities. Possible Directions and Themes are: The migration and /or cross fertilization of sport practices, institutions and celebrities across cultural and national boundaries and their impact on the socio-cultural life of groups; The diffusion, role and take-up of globalizing health practices on the everyday lives of ordinary people and the mechanisms through which this occurs; How different kinds of skilled transnational migrants are influenced by and in turn shape the dominant cultural, political and other forms evident in the host society; How poor economic migrants, who retain strong ties to their societies and cultures of birth, nevertheless forge multiple identities through engagements with members of the host society or with migrants from societies different from their own; The borrowing, mixing and/or hybridization of genres, styles or practices across ethnic/national borders in any field of the arts, film, music, literature, theatre, dance etc - and the origins, vehicles and outcomes of and for such cultural mobilities; Becoming or being cosmopolitan through engaging in globalizing leisure or lifestyle practices; Travel and tourism as paths into global lifestyles and the encountering the cultural other; Globalizing lifestyles and identities and their possible links to the expression of varying forms of political protest.

Religion and Ethnicity between West Africa and Europe: A Transnational Feedback Loop?

Date: June 6-8, 2011 **Site:** Lublin, Poland

Organiser: Prof. Jørgen S. Nielsen, Centre for European Islamic Thought (CEIT), and Dr Niels Kastfelt, Centre for Africa Studies (CAS), Faculty of Theology, University of Copenhagen, Denmark; Dr Stanisław Grodź, Department of the History and Ethnology of Religion, Faculty of Theology, Catholic University of Lublin, Poland; Prof. Martha Frederiks, Department of Theology, Faculty of Humanities, Utrecht University, Netherlands.

Topics: The purpose of this interdisciplinary workshop is to investigate the impact specifically of migration from this region of West Africa into Europe and the effects back into the region. Among questions the workshop aims to consider are: What ideas, models, visions, expectations, fears, and experiences do the migrants bring with them to Europe from West Africa? How strongly are they rooted in their indigenous worldview? What is more important for them – an "ethnic" or "religious" component of their identity (if they differentiate)? How does the European context affect migrants'/immigrants' sense of their own role and identity both in relation to the European environment and in relation to each other? How do networks across the two regions impact on the local situations and how are the networks themselves impacted? And how does it affect the relationships, especially those between Muslim and Christian, in the countries and regions of origin? Does the European experience bring on a change in inherited relations and mutual images, and how do the migrants'/immigrants' own experiences impact on their European environment? How are the effects of resettlement in West Africa from Europe?

Coloniality, Slavery and the Holocaust: Introducing the Decolonial Option

Date: June 4-19, 2011

Site: Middelburg, the Netherlands

Organiser: Utrecht Summer School, the Roosevelt Academy

Topics: 'Coloniality, Slavery and the Holocaust: Introducing the Decolonial Option' is a pioneering course in the social sciences and the humanities. The events of slavery and the holocaust illuminate the geopolitical sources of decolonial thinking in the Global South and critical thought in the Global North. The course builds a dialogue between these currents of thought, and introduces the decolonial option as a path towards global justice. The seminar brings together notions such as disposable life in the economic domain and bare life from the political domain. The first comes from decolonial thinking while the second from critical thought. The course benefits from the local history of Middelburg, a city that was central in the Dutch history of Slavery and that suffered great destruction during the 'Second World War'. The course will also explore the relations between museums and the coloniality of representation and memory by analyzing museums such as the US Holocaust Memorial Museum and International Slavery Museum at Liverpool. The participants will: 1) get acquainted with the major debates in critical and decolonial thinking, 2) understand the decolonial option in light of the synergies and divergences between 'global north' and 'global south' perspectives, 3) reflect on key issues of global justice, 4) learn to situate knowledge in relation to local and global histories and 5) develop their ability to produce critical and committed research in the Social Sciences and the Humanities.

Summer School on Migration and Remittances in Central Asia. Theoretical Aspects and Empirical Research

Topics: The Osteuropa-Institut Regensburg (OEI) in Germany in cooperation with the VW Foundation invites applications for a summer school on Migration and Remittances in Central Asia. Courses concentrate on theoretical aspects of migration and remittances as well as on applied research in these fields with a particular focus on Central Asia. Students will be introduced to ongoing scholarly debates on the incidence, the determinants, and the destinations of internal and international migration movements in Central Asia and on the relevance and impact of remittances in this region. The students will learn how information on migration and remittances can be gained and analyzed and will acquire theoretical and practical knowledge on such topics as conducting surveys and interpreting the results of statistical data analysis. The program also offers participants the opportunity to present and discuss their own research in a professional environment. Accordingly, participants are expected to engage actively in presentations and discussions and to prepare a short presentation (15 minutes plus discussion) on a topic related to the general themes of the Summer School. The Summer School is open to advanced BA, MA and PhD students and young researchers from Central Asian countries studying economics and related disciplines in the social sciences with a strong interest in the issues of migration and/or remittances. Avatars of Intellectuals under Communism, History of Communism in Europe

Place of publication: Bucharest, Romania Type of publication: print, online Published by/ edited by: Zeta Books

Topics: The next issue of the History of Communism in Europe welcomes original contributions on this topic. Ideally, the authors should address the role of the intelligentsia from a comparative viewpoint. The editors encourage young scholars, in particular, to assess the recent historical, cultural, and political findings within the former Soviet Bloc: Romania, Hungary, Czech Republic, Slovakia, Bulgaria, Poland, former GDR or various states of the former USSR or Yugoslavia. The editors welcome any contribution that describes the attitude of Western intelligentsia towards the birth, the growth, and the historical decay of the Communist utopia. Senior scholars, researchers and PhD students are invited to submit their proposals on one of the following topics: Intellectuals and the Communist Party: doctrinaires, utopian revolutionaries, critiques, and dissident thinkers; Dissidence vs. collaboration; The alternative culture vs. official culture under Communism (this may also include reference to recordings and archival documents about the activities of various literary and artistic bodies); The phenomenon of samizdat (the grassroots strategies eluding state-imposed censorship on intellectual products); Readings of Western intellectuals in relation to Communist utopia (How did various philosophers, writers, and journalists justify the works of the authoritarian and totalitarian States behind the Iron Curtain?): Fellow travelers in Communist countries, stories about organized trips to Soviet Union and other communist countries, presented to Western guests as morally neutral, if not benevolent societies (subsequent topics in epistemology: the construal of the Other, the culture of Self-Hatred, etc.); Media and intellectuals under communism. This may include references to powerful alternative media vehicles (i.e. Radio Free Europe), but also to the widespread phenomenon of sponsored journalism; Reading the past after 1989 through intellectual lenses (recollections, mémoires, diaries, personal archives).
