Of Cosmopolitanism and Cosmologies

Organiser: Czech Association for Social Anthropology (CASA), Slovak Association of Social Anthropologists (SASA) **Topics:** The organizers invite scholars and students of social anthropology and related disciplines to address the following questions and to develop their own themes for panels focusing directly or indirectly on the anthropological investigation of cosmopolitanism, understood most broadly as a historically, socially or culturally situated phenomenon: The narrative of internationalism during socialism operated sometimes explicitly in opposition to cosmopolitanism. What is the plight of this narrative after 1990? Conceptions of self and "other" are often revealed in relation to cosmological settings. What are the current ontologies of self and other in post-socialist Europe? The "culturalization of poverty" could be seen as a new millennial narrative. How can we read this global escape to culture against existing social inequalities?; Kant linked cosmopolitanism to the principle of universal hospitality. What could be made of that link if we take into account the renewed interest of anthropology in hospitality?; Do new religious movements influencing various marginal groups in CEE reveal any cosmopolitan ethos?; In the increasingly interconnected and complex world new cosmo-political alliances and identities have been forming across social and environmental movements (around issues such as global poverty, climate justice, agriculture etc.). How are the local and trans-local loyalties and stakes played out in these movements?

Summer School in Holocaust Studies: "The Diverse Survival Strategies of Jewish and Roma Communities in Macedonia: From Resistance to Memorialization"

Date: September 26-October 3, 2011 Site: Ohrid, Republic of Macedonia

Topics: The central interest of the School is focused on opening up the discussion about the memorialisation of the Holocaust experience in Macedonia, and in particular focusing for the first time on Roma people as victims of genocide violence, by taking the Holocaust as an important factor in the formation of Macedonia's historic and socio-cultural past. The presence of the Jewish narrative in Macedonia will be compared to the scarce but important data on Roma people among other minority groups - victims of the Holocaust (homosexuals, disabled people, etc.). By promoting the memorialisation of Jewish and Roma experiences in a comparative perspective from the Macedonian context and their "strategies of survival", in this Summer School the organizer takes as a starting point an attempt to further thematise and raise awareness of the systemic violence of the Holocaust through interdisciplinary academic discussion.

Identity Studies: Political Theology Place of publication: Tbilisi, Georgia

Topics: The issue will focus on social, anthropological, political, cultural, religious studies regarding political theology. Political theology is an ancient term, but it received its modern significance in the 20s of the last century thanks to the work by Carl Schmitt, for whom it was itself a political i.d. war concept. After undergoing transformations and acquiring new connotations within the Catholic and Protestant theologies, the terms tended in the last decades to acquire a more descriptive meaning, designating the intertwining and intersection between theological and political discourses, between religious order and political community.
