Topics: The Organizing Committee invites to submit proposals dealing with one of the three topics summarized below. Topics: At the conference, the first copy of the new version of the Atlas of European Values will be presented to Mr. Herman van Rompuy, President of the European Council. The Atlas of European Values reports on how Europeans think about life, family, work, religion, politics and society and is based on the integrated data file of the most recent European Values Study surveys in all 47 countries in Europe. This unique dataset enables to address issues of how diverse or united Europeans are when it comes to basic human values. Combined with the earlier waves of the European Values Study, trends in value patterns over almost 30 years can be studied. The organizers invite international scholars to reflect on European values, the diversities and trends in Europe, and to elaborate theories, derive hypotheses from them and to empirically test these theories in the various value domains, preferably using the data from the European Values Study, but other data sets may be used as well. Topics include family and marriage, work and leisure time, religion and morality, politics and society, and identity and ethnic diversity. Methodological papers on international and longitudinal comparative studies of values are also welcome.

Topics: This year's Forum will be focused on the functional regions as a new paradigm of territorial and cohesion policy. It is related to the now ongoing works on the new shape of the European cohesion policy. Greater flexibility in delimitation of units that are primary focus of that policy is postulated, among others, in the Fifth Cohesion Report. The new results obtained from the evaluation studies carried out in the previous programming periods attest to the importance of adopting the new approach to the European space. A functional region constitutes a space whose basic element is different from a traditionally understood sectorial specialization. Its determinants are, to an increasingly larger extent, made up of such elements like size, directions and structure of linkages and flows. Interestingly, as regards the last, these can be both inner flows (commuting to work and services of general interests, production chains) as well as outer flows (trade exchange, migrations), including often the processes of global significance.
