The European Union and the Politicization of Europe

Date: December 8-10, 2011 **Site:** Vienna, Austria **Organiser:** Euroacademia

Topics: The Euroacademia International Conference aims to survey some of current debates and addresses once more the challenges of the EU polity in a context of multiple crises that confronted Europe in recent years. It supports a transformative view that involves balanced weights of optimism and pessimism in a belief that the unfold of current events and the way EU deals with delicate problems will put an increased pressure in the future on matters of accountability and will require some institutional adjustments that address democratic requirements for decision making. However in its present shape and context the EU does not look able to deliver soon appropriate answers to democratic demands. In a neo-functionalist slang one can say as an irony that the actual crisis in the EU legitimacy is a 'spillover' effect of institutional choices made some time before. To address the EU's democratic deficit however is not to be a sceptic and ignore the benefits that came with it but to acknowledge the increasing popular dissatisfaction with 'occult' office politics and with the way EU tackles daily problems of public concern while the public is more and more affected by decisions taken at the European level. The conference is organized yet by no means restricted to the following orientative panels: The Politicization of Europe: Desirable or Contestable; Is the EU resembling an Enlightened Despotism?; The EU as a Political System: Features and Curiosities; Redistributive Policies Inside the EU and their Impact on the Medium Voter; European Elections and Strategies for Politicization; European Parties and Party Politics in the European Parliament; Strategies for Bringing European Issues to Public Scrutiny; The Democratic Deficit Issue: A Persistent Anomaly?; In Search of a European Demos; Looking for a European Civil Society; Appropriations and Politicization of Wider European Values and Narratives; Persisting Intergovernmentalism?; EU and Traces of Imperial Politics; EU and identitarian appropriations; Scenarios for Change Inside the EU; The Future of EU Enlargement; Taking Euroscepticism Seriously; Increasing Public Saliency for Supranational Issues; Lobbying and Policy Making Inside the EU.

Opening the Boundaries of Citizenship

Date: February 6–7, 2012 **Site:** Milton Keynes, UK

Organiser: European Research Council (ERC) funded OECUMENE Project, Faculty of Social Sciences, and the Open

University

Topics: The conference aims at exploring forms of political subjectivity that remain unmapped when citizenship is assumed as just 'membership of the state', as a synonym for nationality, or when conceived as a practice, it is still understood as a contractual, secular, modern and particularly occidental way of belonging. Contrary to the assumption that only a Western model of society (opposed to Hindu, Muslim, indigenous, etc.) could develop the form of political participation in the public sphere called 'citizenship', citizenship can be considered as an ongoing process through which subjects constitute themselves as political, and appears to be open towards its future configurations. In line with the general topic of the symposium, the conference invites contributions addressing the performative and creative side of social movements, practices of identity negotiation and political participation questioning the meaning of citizenship. Which actors, sites and rights are constituted in contemporary power struggles redefining 'the political'? Which neo-colonial or neo-imperial nodes emerge from the analysis of issues such as democracy or secularism? Under this light, how is the language of law challenged and remoulded? Topics of interest include, but are not limited to: Migration politics; Religious identities; Debates on secularism; Women's movements and writing; Feminist, G&L and queer interventions on citizenship; Citizenship, race and colonialism; The sexualisation of democracy; The performance of politics; Contesting public spaces; Art, culture and politics; Multiculturalism and cosmopolitanism as modes of administering of difference.

Reshaping Power, Shifting Boundaries

Date: July 8-12, 2012 Site: Madrid, Spain

Topics: In a globalising world, everywhere power is being reconfigured, creating opportunities for change: New players are emerging on the world stage, reflected in G-20, the 'BRICs' and in North-South relations; Climate change and the financial crisis have altered global dynamics; Transnational governance is taking on new forms, such as the reformed EU and Mercosur; Within states, there is increased devolution and the recognition of subidentities; State functions are increasingly being shared with non-state actors such as corporations and non-governmental organisations and are affected by the dynamics of an international society; Substantial changes are taking place in social life including gender roles and the nature of the family; Religious cleavages refuse to disappear, and may be evolving into a major axis of political and social conflict; The Westphalian model of interstate relations is not sufficient to cope with the challenges of global governance. This emphasises the importance of the dialogue between political science and international relations. The nation-state remains the key crucible of power in terms of elections, public policy and in international negotiations, but it faces new challenges. Territory and power no longer align. Boundaries and borders are shifting. The main congress themes are: Comparative Politics and Political Institutions; Gender, Religion, Identity; International Political Economy; International Relations; Political Behavior; Political Theory; Public Policy.

Topics: The aim of this session is to put population decline, and resulting challenges, responses, and possible consequences more in focus of the international research agenda. Papers for this session should therefore address one or more of the following questions: Which patterns of (national, regional, urban) population decline can be observed?; Which specific challenges result from declining population numbers? (E.g.: to territorial cohesion); How exactly pose declining populations challenges that are different from challenges resulting from growing populations?; Which aspect of population decline is most problematic? (E.g.: the expectation of decline, tempo, scope and volatility of the process itself or its result: smaller populations); Which social fields are vulnerable to shrinking populations? (E.g.: infrastructures of the welfare state such as child care, education and health units; public administration, business organisations, the family); Which responses to declining populations can be observed?; How can responses to declining population numbers be classified and explained?; Which consequences result from population decline and specific response patterns (on a national, regional, urban, organizational, individual level)?; Is it desirable and possible to develop a middle range theory of possible consequences of population decline? Especially welcome are paper proposals based on comparative empirical research and theoretical contributions that systematically reflect the relationship of demographic changes and social institutions and infrastructures.

Inter-organizationalism in International Relations: Theories and Cases

Topics: This two-day expert workshop seeks to bring together scholars and practitioners working on interorganizational relations from a wide range of perspectives and disciplines in order to advance the collective build-up of a self-consciously IR-focussed theory of Inter-organizationalism. The organizers of the workshop are particularly (but not exclusively) interested in a multi-level analysis approach (focusing on factors at the individual, organizational/bureaucratic, member state and international system levels) in order to address the following questions. Core questions may include: Which factors explain the formation/cessation of an inter-organizational relationship?; What are the commonly identifiable core stages of an 'IO-IO life-cycle' – to what extent do they provide different answers to the level of cooperation and competition amongst IOs?; How can we explain interorganizational convergence, cooperation and rivalry?; Which factors explain the effectiveness/ineffectiveness (external impact or lack thereof) of an IO-IO partnership?; How can we explain the interaction and relevant importance of different levels of analysis (i.e., leading member states, principal individuals and executive heads, bureaucratic cultures, inter-organizational committees and core events at the international system)?; Are some policy areas more amenable to effective inter-organizationalism than others (such as security) and if so, why?; What major lessons can be drawn from a wide range of case studies on inter-organizationalism.
